re: Comment and information on Agenda Item 50. - consideration of ORD24-2 to reclassify Park Trailers (Health & Safety Code §18009.3) aka "Tiny Homes On Wheels" (THOWs) as permanent dwellings.

Honorable Supervisors of Nevada County:

First, my apologies for not commenting on this matter sooner. Though I have lived here in beautiful Nevada County since 2020, my full time law practice -- which involves cases in locations all over the State of California but not locally-- has kept me extremely busy, and I had not noticed this particular matter until reading an article in the Union yesterday. That said, when it looks like a big mistake may be made its still "better late than never." Because of work commitments I'm not sure if I can attend your meeting in person. The following is submitted by me personally as a resident of Nevada County and not on behalf of a client. I appreciate your careful consideration of this comment and information.

For context I should mention that the nature of my past practice informs the comment submitted here. I have worked in municipal law in various capacities for a little over 40 years. My early years were in the "public sector" - I was the Assistant City Attorney for the City of Redding for about 10 years, and also actively represented north state water agencies for about 25 years. After leaving the City Attorney's office I went into private practice and have focused on representation of consumers, small businesses and building trade organizations around the state that have issues with public agencies concerning fees/exactions and land use matters. Then, as a somewhat unexpected diversion from my usual work, in the last five years I have worked on several cases in northern CA (Chico, Eureka, and Santa Cruz) involving homeless issues related to drug paraphernalia distribution, land use and homeless housing.

COMMENT

In summary, the proposed ordinance before you is (1) illegal/void due to preemption by State law, and besides that it is (2) the wrong policy for (a) providing low/moderate income housing outside of the "homeless" context, and (b) has a track record of failure for getting "homeless" people off the street or out of shelters.

ILLEGALITY

(1) The proposed ordinance is in irreconcilable conflict with Health & Safety Code §18009.3; the State law makes no provision for converting Park Trailers into permanent human residences; and the State law clearly preempts any conflicting local ordinance such as the one you are considering.

Health & Safety Code §180093.3(a) [see attached] states quite plainly that: "Park trailer" means a trailer designed for human habitation for recreational or seasonal use only, that meets all of the following requirements:" (emphasis added) Your Planning Commission staff report (at p. 2, second paragraph) states: "Tiny Homes on Wheels are categorized as Park Trailers (PTs), defined in California Health and Safety Code Section 18009.3. The basic physical limitations for the size and occupancy space, single chassis, non-powered, and DMV registration requirement of Park Trailers in Health & Safety Code §180093.3(a) are replicated in your proposed ordinance at Section 12.03.310 B.1. (For consistency I will refer to Park Trailers as representative of both Park Trailers and Tiny Homes on Wheels (THOWs, notwithstanding that THOWs have lots of external design requirements that are immaterial to this analysis). Park Trailers are factory-built to manufacturer industry standards (ANSI Standard A119.5 Recreational Park Trailers) but are not required to comply with California Building Code standards otherwise required for dwellings for permanent human habitation. There is nothing in Health & Safety Code §180093.3, or elsewhere in the State law, that allows Counties or Cities to reclassify Park Trailers as permanent dwellings.

It would appear that your planning staff have been given or adopted on their own a grossly inaccurate legal interpretation of the leeway given to to Counties and Cities to regulate the the use of Park Trailers, as if it included a new power to convert them into permanent dwellings. The Planning Staff Report relies on the following quote from an HCD Bulletin:

"Generally, "PTs, like [recreational vehicles] RVs, are designed as temporary living quarters for recreational and seasonal use only, and not as a year-round or permeant dwelling ... and [u]nless otherwise allowed by local ordnance, PTs generally may be only occupied in mobile home parks or special occupancy parks, governed by the [Mobile Home Parks Act] MPA" (HCD Information Bulletin 2016-01)."

Unfortunately the report falsely conflates the the phrase "unless otherwise allowed by local ordinance" as granting power to change Park trailers into permanent dwellings, rather than the applying it as written to the remainder of the statement from the Bulletin which describes where the Park Trailers may be occupied - which ordinarily is confined to "special occupancy parks."

To repeat for emphasis, there is no law, statute or regulation

pertaining to Park Trailers that allows a County to adopt an ordinance to convert them to permanent housing. There is however very explicit authority under the Special Parks Occupancy Act (Health & Safety Code §18860 et seq.) for the County to not only take over responsibility for enforcing the State laws applicable to the Parks, but also to adopt regulations applicable both inside and outside the Parks, within the reasonable exercise of their police powers", such as (see Health & Safety Code §18865(g)): creating zones where parks may be located; regulating signage, perimeter walls, vehicle parking; prescribing the prohibition of certain uses for special occupancy parks; regulating construction, disposal of sewage or other waste; requiring a permit for use of a recreational vehicle (Park Trailers) outside a park, collect fees for the permit, revoke a permit for violation of the state and local regulations. Thus the County has wide ranging authority to adopt ordinances and resolutions that regulate the uses of Park Trailers anywhere in the County, provided that the County's regulations don't contravene State law. The County has no power to change the very nature of a Park Trailer as "a trailer designed for human habitation for recreational or seasonal use only." (Health & Safety Code §18009.3)

In this respect it should be clear that State law preempts and controls local authority, which otherwise is given leeway to "fill in the blanks." Health & Safety Code §1805 provides: "The provisions of this part apply to all parts of the state and supersede any ordinance enacted by any city, county, or city and county which conflict with the provisions of this part."

The only legislation I am aware of that allows Counties and Cities to bypass fundamental building standards is the "Shelter Crisis, Emergency Bridge Housing Communities" law (Gov. Code §8698 et seq.), which you may know of. That collection of statutes suspends building and planning laws, with the bare minimum of health and safety protection, allowing all sorts of small structures to be used for housing of the homeless. And there are a large number of cities and counties that have gone into that program. The "catch" is that the County would have to officially declare a "Shelter Crisis," which injects the County into a State program that requires detailed reporting, broad provision of homeless services, and commitments to transition the homeless occupants to traditional permanent housing even though funding for that step is not necessarily provided by the State. To my understanding Nevada County has not adopted a "Shelter Crisis" resolution to enter such a program (and I would recommend against doing so). In addition, it provides no benefit to the low/moderate income people who simply can't find available housing because what housing stock may be available is priced beyond their means.

Your staff report (for the Planning Commission) references review of Tiny Homes Ordinances adopted in other counties like Placer, Sonora, Mendocino, and Santa Cruz. Without review of the actual ordinances mentioned I can't tell you with certainty what those ordinances entail: whether they are ordinances for Tiny Homes that are free-standing and subject to the Building Codes as opposed to the Park Trailer RVs; or ordinances that merely regulate the activities permitted at

special occupancy parks or RV permits outside of parks; or ordinances that provide for tiny homes under a "Shelter Crisis" declaration. Its not impossible but I doubt that any of those ordinances provide that Park Trailers can be used for permanent residential occupancy in direct contravention of State law.

Of course, as an attorney, I looked in the beginning of my research to see if there is any case law addressing this subject. I did not find any citable case law, which indicates only that there are few people with the interest or resources to litigate a question of this kind through the appellate courts. After completing my research, just as an excise to check conclusions, I ran the question through my Lexis Nexis AI software. The AI search turned up an unpublished case, *Anderson v. Staples*, 2010 Cal. App. Unpub. LEXIS 8021, which supports my opinion above, and an AI review of the statutes which supports my which supports my opinion generally. (see attached) While I would not pretend that I could introduce AI search report answers as admissible evidence in court, I thought you should know that my research on this subject was exhaustive.

Along with my initial apology for coming late to the discussion, I find it extremely unfortunate that both you as Supervisors and the public in general have (innocently) invested so much time and effort in this well-intentioned endeavor, only to find out it isn't feasible to begin with. The proposed ordinance can't be "fixed" to make it conform to State law. With that said, I don't believe the passion to improve and expand affordable housing opportunities should be lost. Where there is a will there is a way, and I would be glad to help you in that if I can.

THIS IS NOT THE RIGHT POLICY TO ADDRESS THE HOUSING SHORTAGE

1. LOW/MODERATE INCOME HOUSING GENERALLY

I have the greatest respect for and share the concerns of the community that we have a tremendous unmet need for affordable housing. I also believe that pursuing a program that's "better than nothing" does not mean that its "good enough" (or in this case legal).

My quarrel with using RVs as permanent housing is that they just aren't built to be permanent and withstand the wear and tear of daily ongoing use beyond the short term. They break down far more quickly than if they were used for just recreational and seasonal use. (No doubt part of the rationale for the state law limiting their usage.) If the occupant of an RV is low income, it would be difficult maintain, repair or replace what breaks down, and --without any value judgement-RVs that fall into disrepair (1) turn into a form of "blight" for the surrounding community, and (2) are fundamentally a disservice to the occupants who are languishing in substandard housing that was predictably a consequence of a policy approach that we knew would founder.

I can't say I have the magic solution, or one that would please everybody. But I do believe there are solutions, whether one or several, that can provide quality housing for low/moderate income people. One approach I have studied recently is the construction of new apartment buildings specifically dedicated to low/moderate income tenants; the key to it is participation by public and private actors who engage a federal program that helps finance construction through syndicated sales of tax credits on the financing, making the whole project financially feasible.

I'm sure there are other options. What I suggest as a bottom line is that occupants of new housing be given a home that is affordable, comfortable, safe, and durable for the future.

2. HOUSING FOR THE HOMELESS

Though not spoken out loud, the subtext of public discussion is that Park RVs could be a solution to provide housing for the homeless to give them permanent homes. My comment, which well intentioned passionate supporters of homeless housing are free to debate, is that experience in California teaches us that the persistent or "chronic" homeless can only be helped by a multi-prong approach.

It is well known that most of the chronic long-term homeless suffer from "co-morbidities" -- either drug addiction or mental illness, or both. California's pursuit of two polices, "Housing First" and "Harm Reduction," and the absence of a third -the lack of mental health treatment, have collectively been a disastrous failure. The "Housing First" strategy, as the primary solution largely to the exclusion of all others, provides housing to chronic homeless on the supposition that a secure environment will take care of their insecurities and lead to an overall wellness that puts them on a path to independence and good health. "Housing First" fails because, taken alone, the homeless individual is unchanged; the housing is degraded or destroyed; and the self-destructive pattern of the homeless revert to the baseline. Not to mention that the he cost of Housing First, where actually practiced, has proven unsustainable. "Harm Reduction" then exacerbates the homeless condition by providing unlimited supplies of drug paraphernalia that facilitates drug addiction. The Harm Reduction policy promotes an ethos that the drug addicted should be treated normally, left to their addiction. and the decision to seek treatment is left to them if they ever come to it. The result is continued addiction, and growth of the ranks of the addicted. The third policy failure is the absence of publicly available mental health treatment in California. Those who have been traumatized by life's events may sink into mental illness, only to find themselves traumatized again by becoming homeless.

It is not a revelation to point out that homelessness, drug addition, and mental illness are synergistic self-reinforcing factors. If they are not addressed all at the same time, If one or two factors are addressed in isolation, the untreated factor will push back on the others and all progress will be lost.

Getting back to the point of this - which is your consideration of an ordinance that seeks to expand housing by attempting to allow Park Trailers as permanent residential structures -- the well intentioned effort of this ordinance, insofar as it is arguably aimed at housing for the homeless, cannot succeed overall without a congruent policy for treatment of drug addition alongside a policy for treatment of mental illness. As I say that I know that the County does not have funding for drug addiction treatment, nor funding for mental health facilities, nor funding to gratuitously provide housing on your own dime (so you have an ordinance before you that allows others to set up Park Trailers as if they were permanent housing actually in violation of State law).

I don't have an immediate answer for the lack of funding to push forward a three pronged approach that's necessary to address homelessness. I can only suggest that you instead seek out and assist (legal) innovative builders that can leverage the pent-up demand for housing in this area, which would improve the situation for all if more low/moderate income housing is created. And in the same vein continue to look for creative mechanisms to chip away or do "proof of concept" all the rest to be accomplished.

§ 18009.3. "Park trailer" requirements

- (a) "Park trailer" means a trailer designed for human habitation for recreational or seasonal use only, that meets all of the following requirements:
 - (1) It contains 400 square feet or less of gross floor area, excluding loft area space if that loft area space meets the requirements of subdivision (b) and <u>Section 18033</u>. It may not exceed 14 feet in width at the maximum horizontal projection.
 - (2) It is built upon a single chassis.
 - (3) It may only be transported upon the public highways with a permit issued pursuant to <u>Section 35780 of the Vehicle Code</u>.
- (b) For purposes of this section and <u>Section 18033</u>, "loft area" means any area within a unit that is elevated 30 inches or more above the main floor area and designed to be occupied. In order for the floor of a loft area to be occupied and excluded from the calculation of gross floor area for purposes of subdivision (a), the loft area shall meet all of the requirements of <u>Section 18033</u>. Loft areas not meeting the requirements of this subdivision and <u>Section 18033</u> shall not be occupied and shall be posted with a permanent label conspicuously located within 24 inches of the opening of each noncomplying loft. The label language and design shall provide the following:

WARNING

This area is not designed to be occupied and shall be used only for storage.

Lettering on this label shall contrast with the label's background and shall be not less than one-quarter inch in height, except for the word "WARNING" which shall be not less than one-half inch in height.

- (c) A park trailer hitch, when designed by the manufacturer to be removable, may be removed and stored beneath a park trailer.
- (d) If any provision of this section or <u>Section 18033</u> conflicts with ANSI Standard A119.5 Recreational Park Trailers as it is published at any time, the statutory provision shall prevail.

Can you find any instances, whether in cases, statutes, regulations, or Attorney General Opinions, where "park trailers" -see Health & Safety Code §18009.3 - were permitted to be used for permanent residency as opposed to seasonal or recreational use?



Al Assistant

Based on the provided documents, there is no clear instance where "park trailers" as defined in § 18009.3. "Park trailer" requirements are permitted for permanent residency. According to § 18009.3. "Park trailer" requirements, a "park trailer" is specifically designed for human habitation for recreational or seasonal use only and must meet certain criteria, including size and transportability requirements § 18009.3. "Park trailer" requirements.

Additionally, in the case of Anderson v. Staples, 2010 Cal. App. Unpub. LEXIS 8021, the court noted that both the County and the City did not permit park model RVs to be used as permanent homes, reinforcing the interpretation that park trailers are not intended for permanent residency. Anderson v. Staples, 2010 Cal. App. Unpub. LEXIS 8021.

Furthermore, § 18010. "Recreational vehicle" also defines "recreational vehicle" to include park trailers. emphasizing their use for recreational, emergency, or other temporary occupancy § 18010, "Recreational vehicle".

Therefore, the statutes and case law provided do not support the use of park trailers for permanent residency in California.

The time is Now

Dear Supervisors -

I won't be able to attend the meeting this coming Tuesday but I want to voice my support for allowing THOW's and also urge you to consider legalizing AHOW's. Aside from the obvious need for low income/affordable housing in our county I have a different aspect to consider.

I own a nice 5th wheel trailer that would be suitable for living in and a large parcel with access to septic for the trailer. We have been unable to sell our rig as the market is at rock bottom and we are facing a 50% loss. If the county were to ease the restrictions we could recoup some of that loss by offering it for rent which would also help someone in need of affordable alternative housing. I know there are many other RV owners in this county that are of the same opinion.



The case for All Homes on Wheels housing

Low wages, high rents and lack of affordable housing are the primary cause of the homeless/housing crisis, according to the seminal <u>California Statewide Study of People Experiencing Homelessness (CASPEH)</u> from the University of California, San Francisco. More than half of our homeless population attribute the high cost of housing as the main cause of their homelessness, the UCSF study said.

Lose your job, lose your home.

Most homeless people don't look or act homeless. They try hard not to be labeled and stigmatized as homeless, but they are living lives of quiet desperation.

The numbers vary widely, but reliable sources ranging from the UCSF study to the federal <u>Substance Abuse and Mental Health Services Administration</u> to internationally respected website <u>InvisiblePeople.iv</u> agree that far fewer than half of all homeless people are substance abusers or suffer from mental illness.

Besides the inability to find or afford housing, people become homeless for reasons such as release from institutions with no resources, accident or illness, domestic violence, trauma, abandonment, runaways, abuse, discrimination, natural or human-caused disaster, criminal mistakes, poor choices and bad luck.

Nobody gets out of homelessness without help. It's extremely difficult to heal, regroup, stay clean, start over, find a job, raise children, go to work or school when you have no safe place to, as one homeless man put it, "shit, shower and shave."

Housing First, Housing Now for its citizens must be Nevada County's highest priority.

HOW AND WHY

Nevada County's proposed finy homes on wheels (THOW) ordinance is a well-intentioned step toward mitigating the lack of housing, but it does not go far enough. It does not meet the immediate housing needs of the low-income workforce, much less people on fixed incomes who are aged and/or disabled.

The proposed THOW ordinance must be amended to include "all homes on wheels" (AHOW) – trailers, RVs and mobile homes. They are functionally the same as THOW units and are subject to the same DMV licensing requirements.

In the face of this homeless/housing crisis, AHOW units that meet codeequivalent, minimum health and standards must be legalized. We have a homeless/housing emergency. AHOW housing presents the opportunity to offer real affordable housing to our citizens who are most at risk of homelessness.

DECLASSIFICATION

The elephant in the room when discussing the inclusion of trailers, RVs and mobile homes in the THOW ordinance is the elitist myth that "trailers" and the people who live in them are undesirable.

It is grossly unfair and unacceptable to deprive people of housing because of prejudicial NIMBY beliefs. This is a civil rights issue. Everybody has a right to housing.

Homes on wheels may not be the ideal solution, but to meet immediate, low-income housing needs, they are the best solution.

CODE COMPLIANCE

Thousands of Nevada County residents are already living in AHOW alternative housing units (AltDUs). They live in secrecy, fearing any complaint could cause the disruption and forced relocation of their lives, families and/or jobs.

Code Compliance's enforcement of arbitrary rules and regulations based on meritless and malicious complaints does not serve the public good.

Forcing people to move does not solve the problem. It creates a bigger, more expensive problem for the tenants, the landlords and the county.

Instead of moving people, Code Compliance's top priority should be to make people safe where they are. The Code Compliance director should exercise his "sole discretion" not to act on malicious and mean-spirited complaints.

Property owners' rights end at their property line. They must not have the right to infringe on a neighbor's right to offer AHOW housing.

NEVADA COUNTY LEADERSHIP

Nevada County is essentially copying the Placer County THOW ordinance. Nevada County can do better. As a leader among rural counties, Nevada County should model the innovative and cost-effective adoption of an AHOW ordinance that would truly be a meaningful mitigation of our rural homeless/housing crisis.
