An Overview

Last year, the \$3 million included in the state budget as part of a drug overdose prevention effort was used to establish CDPH's Naloxone Grant Program.

- ▶ Naloxone: A medication that works almost immediately to reverse opiate overdose. It has
 - ▶ Few known adverse effects,
 - ▶ No potential for abuse, and
 - ▶ Can be rapidly administered via nasal spray

Overview Continued

- ▶ The Center for Disease Control estimated that Narcan kits saved 27,000 lives by reversing fatal drug overdoses caused by opioids.
- ▶ This investment also reduces hospitalization rates for treatment of non-fatal but debilitating overdoses.

Nevada County Data

Hospitalizations Due to Opioid Overdose	35	29	30	32
ED Visits Due to Opioid Overdose	23	18	18	22

We believe that no one should lose their loved one to the disease of addiction if we have the means to prevent it.

The Means

Nevada County Naloxone Grant Program Award:
\$10,631 = 270 doses of Narcan Nasal Spray through 2019



Distribution Plan

Naloxone Distribution System Criteria:

- Work under a standing order from a licensed clinician/medical director;
- Have staff that are trained (or are trained to provide education to others) on:
 1. naloxone storage and administration,
 2. overdose prevention techniques,
 3. how to recognize an opioid overdose (signs and symptoms),
 4. how to respond by calling 911 and provide rescue breathing, and
 5. post-overdose care.
- Dispense naloxone products; and
- Document distribution efforts.

Distribution Plan

- ▶ What is our current capacity to efficiently and effectively provide naloxone and training to first responders?
- ▶ Who is serving individuals at high-risk for overdose and what are their naloxone distribution-related needs?
- ▶ Priority consideration is to be given to SEPs if present in the jurisdiction.
