OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING A RENEWAL CONTRACT WITH MIDVALLEY RECOVERY FACILITIES, INC., DBA PATHWAYS, FOR THE PROVISION OF RESIDENTIAL TREATMENT AND WITHDRAWAL MANAGEMENT SERVICES FOR REFERRED CLIENTS OF NEVADA COUNTY IN THE AMOUNT OF \$450,000, FOR THE AGREEMENT TERM OF JULY 1, 2026, THROUGH JUNE 30, 2027

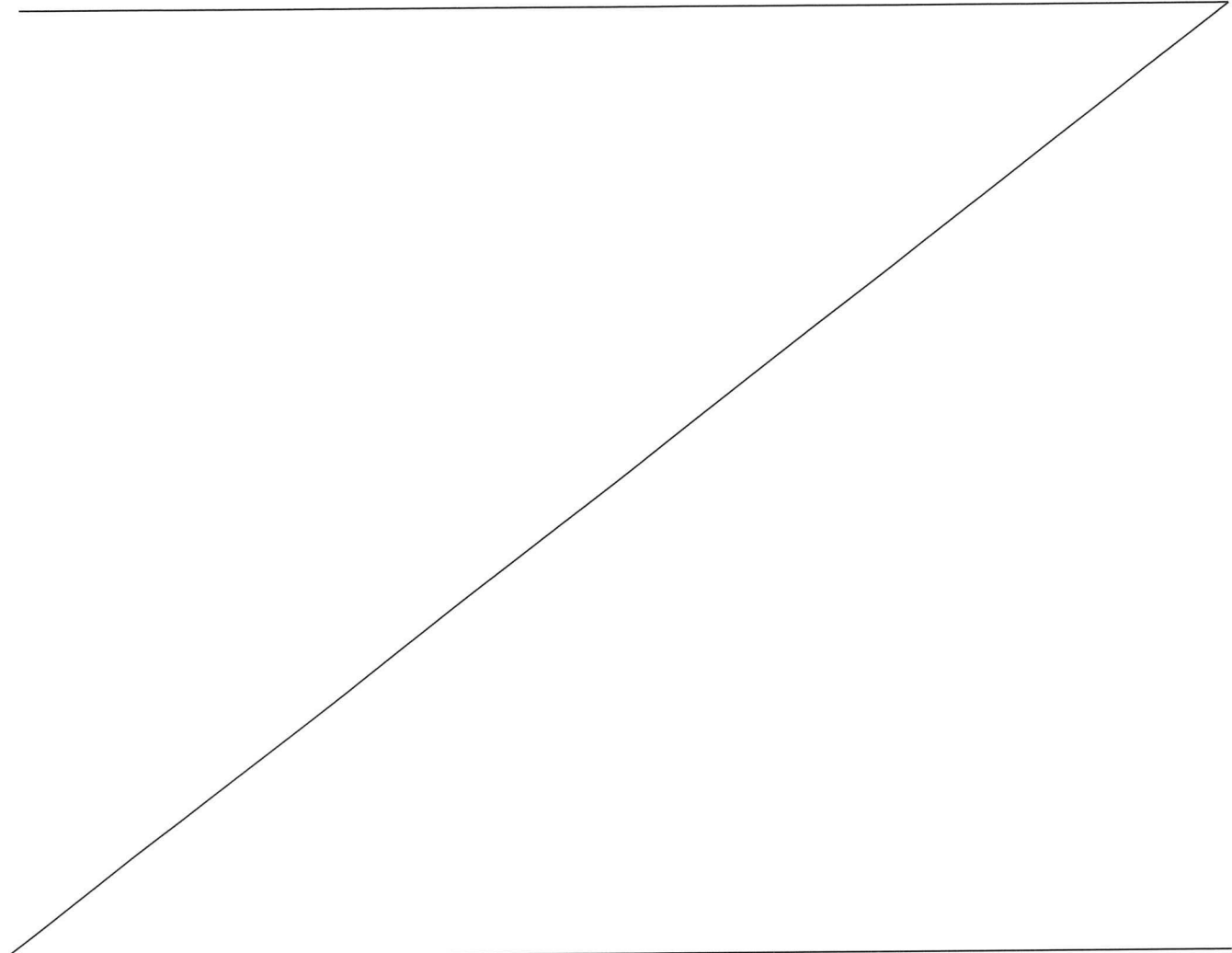
WHEREAS, Midvalley Recovery Facilities, Inc., is a non-profit organization licensed by the State to provide services for the provision of withdrawal management and residential treatment services to treat substance use disorders for adults, over the age of 18, and contract services are funded by the 2011 Realignment and Drug Medi-Cal Federal Reimbursement; and

WHEREAS, under this contact, the Contractor will provide comprehensive treatment program services for adults, including 24 hours a day 7 days a week supervision, residential, and withdrawal management services at the residential facility for referred County clients; and

WHEREAS, the contracted services provide a comprehensive array of integrated and coordinated treatment services that will serve to reduce recidivism and improve long-term outcomes for clients.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Professional Services Contract by and between the County and Midvalley Recovery Facilities, Inc., DBA Pathways, related to the provision of residential treatment and withdrawal management services for referred clients of Nevada County in the maximum amount of \$450,000, for the term of July 1, 2026, through June 30, 2027, be and hereby is approved in substantially the form attached hereto, and the Chair of the Board of Supervisors is authorized to execute the Contract on behalf of the County of Nevada. This contract is contingent upon the adoption of the Fiscal Year 2026/27 County budget. The contract begins on July 1, 2026.


