OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 1 TO THE CONTRACT BETWEEN THE COUNTY OF NEVADA AND INTERWEST CONSULTING GROUP, INC. TO PROVIDE ON-CALL BUILDING INSPECTION AND PLAN REVIEW SERVICES AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE AMENDMENT NO. 1 IN AN AMENDED MAXIMUM CONTRACT AMOUNT NOT TO EXCEED \$200,000 AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE FISCAL YEAR 2019/20 BUILDING DEPARTMENT BUDGET (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, in periods of high building activity the Building Department has a need to utilize additional staffing resources to complete Plan Review and Inspections in a timely manner; and

WHEREAS, a competitive procurement process was conducted and Interwest Consulting Group, Inc. ("Interwest") was selected to provide on-call Plan Review and Inspection services and was approved with Resolution 19-280; and

WHEREAS, services will only be utilized as needed and when sufficient revenue is received to fund the services; and

WHEREAS, services provided by Interwest have thus far been satisfactory; and

WHEREAS, additional services from Interwest are needed in Fiscal Year 2019/20 resulting in a need to increase the contract amount; and

WHEREAS, the maximum contract amount will be increased by \$75,000 and the maximum contract amount will not exceed \$200,000 and be paid from budget code 1123-20602-322-1000/521520.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors of the County of Nevada approves Amendment No. 1 between the County of Nevada and Interwest Consulting Group, Inc. for Fiscal Year 2019/20 in the maximum amount of \$200,000 and authorizes the Chair of the Board of Supervisors to execute Amendment No. 1 on behalf of the County of Nevada.

BE IT FURTHER RESOLVED that the Board of Supervisors of the County of Nevada directs the Auditor-Controller to amend the Fiscal Year 2019/20 Building Department Budget as follows:

**AMENDMENT NO. 1 TO CONTRACT WITH
INTERWEST CONSULTING GROUP, INC.**

THIS AMENDMENT is executed this 24th day of March 2020 (the "Effective Date") by and between INTERWEST CONSULTING GROUP, INC. and COUNTY OF NEVADA (the "Amendment"). Said Amendment will amend the Prior Contract between the parties entitled ON-CALL PROFESSIONAL BUILDING INSPECTION AND PLAN REVIEW SERVICES executed on June 18, 2019 by Resolution 19-280 (the "Prior Contract").

WHEREAS, the parties desire to amend the Prior Contract to allow or provide for additional services; and

WHEREAS, COUNTY OF NEVADA has sufficient funds available for the costs associated with this request.


NOW, THEREFORE, the parties hereto agree as follows:

1. This Amendment shall be effective as of March 24, 2020.
2. The maximum amount of the Prior Contract is increased to a shall not exceed amount of \$200,000.
3. That in all other respects the Prior Contract of the parties shall remain in full force and effect except as amended herein.


