## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

### **RESOLUTION APPROVING EXECUTION OF A RENEWAL CONTRACT WITH SIERRA MENTAL WELLNESS GROUP FOR THE PROVISION OF SERVICES INCLUDING CRISIS INTERVENTION, MOBILE CRISIS SERVICES, AND THE OPERATION OF A CRISIS STABILIZATION UNIT IN THE MAXIMUM AMOUNT OF \$1,454,000 FOR THE TERM OF JULY 1, 2026, THROUGH SEPTEMBER 30, 2026**

WHEREAS, the Nevada County Board of Supervisors authorized the execution of a Contract between the County and Sierra Mental Wellness Group for services in relation to crisis intervention, community client services, and services relating to the operation of a Crisis Stabilization Unit (CSU) for Fiscal Year 2025/2026; and

WHEREAS in March of 2026, through a request for proposal process, a new vendor was selected to provide crisis services beginning in fiscal year 2026-27; and

WHEREAS this contract encompasses the provision of crisis services through Sierra Mental Wellness Group during the transition period, until the new vendor begins providing direct client crisis services starting on September 1, 2026; and

WHEREAS, crisis services are case-driven initial evaluations and referral services for patients needing immediate mental health crisis intervention; and

WHEREAS, in coordination with the Nevada County Behavioral Health Department, a four-bed Crisis Stabilization Unit operates 24 hours per day, seven (7) days per week, where individuals can receive crisis services, including psychotherapy and medication support for up to twenty-three consecutive hours per event; and

WHEREAS, the therapeutic response may encompass multiple approaches, including evaluations according to Section 5150 of the California Welfare and Institutions Code, to evaluate whether a patient is able to function in the community, and if necessary, the Contractor's Crisis Workers are responsible for assisting in the admission and paperwork completion for the patient to enter a psychiatric inpatient facility; and

WHEREAS, CSU and crisis intervention continue to be a need in our community and the parties wish to continue their agreement.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Professional Services Contract by and between the County of Nevada and Sierra Mental Wellness Group pertaining to the provision of crisis intervention and community client services for the term of July 1, 2026 through September 30, 2026, in the maximum amount of \$1,454,000 be and hereby is approved, and that the Chair of the Board of Supervisors is hereby authorized to execute the Contract on behalf of the County of Nevada.
