



# RESOLUTION No. 15-479

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION AUTHORIZING PURCHASE OF A STORAGE AREA NETWORK (SAN) CAPITAL ASSET AND REPLACEMENT OF A CAPITAL ASSET, AND AMENDING THE FISCAL YEAR 2015-16 INFORMATION SYSTEMS BUDGET (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the Chief Information Officer has recommended, and the Information System Steering Board has approved, a project to: a) replace the Storage Area Network (SAN) in the County's central data center with a unit that will enable data encryption and expand the data storage capacity; and b) acquire a SAN for disaster recovery purposes that will provide for offsite replication of live data in order to provide for more reliable disaster recovery capabilities; and

WHEREAS, the manufacturer of the current SAN (Tegile) has agreed to replace that model at no cost to the County with a model that will provide for data encryption and larger capacity at no cost;

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors:

1. Authorizes the replacement of capital asset No. 27170, a Tegile Zebi Storage Area Network, with a Tegile T3200 model valued at \$201,776, at no cost to the County.
2. Authorizes purchase of the following capital asset:  
Tegile T3100 Storage Area Network \$75,000
3. Directs the Auditor-Controller to reduce the Information Technology Assignment of the General Fund by \$42,200 (4/5 affirmative vote required) and amend the Fiscal Year 2015-16 Information Systems budget as follows:
