



# **RESOLUTION No. 25-455**

## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

### **RESOLUTION DIRECTING THE NEVADA COUNTY CLERK-RECORDER/REGISTRAR OF VOTERS TO CONSOLIDATE THE COMMUNITY FACILITIES DISTRICT NO. 1 (TRUCKEE LIBRARY) OF THE TRUCKEE LIBRARY JOINT POWERS AUTHORITY SPECIAL BOND MEASURE ELECTION WITH THE NOVEMBER 4, 2025, CALIFORNIA STATEWIDE SPECIAL ELECTION AND DIRECTING THE CLERK-RECORDER/REGISTRAR OF VOTERS TO SEEK REIMBURSEMENT FOR ADMINISTERING THE ELECTIONS IN ACCORDANCE WITH STATE ELECTIONS LAWS GOVERNING ELECTIONS COSTS**

WHEREAS, on August 21, 2025, the California State Legislature passed, and the Governor of California approved, Senate Bill 280, which called a Statewide Special Election to take place on November 4, 2025; and

WHEREAS, Senate Bill 280 permits any special district that called a special election to consolidate with the California Statewide Special Election, provided that the special local election was called on or before August 8, 2025; and

WHEREAS, on June 23, 2025, the Truckee Library Joint Powers Authority in Resolution 2025-04 and Resolution 2025-05 called a special election, requested the County elections official render election services for the special election, and requested County election officials to consolidate the election with any other election taking place on November 4, 2025; and

WHEREAS, the Nevada County Board of Supervisors approved Resolution 25-377 authorizing the Nevada County Clerk-Recorder/Registrar of Voters to render services for the Community Facilities District No. 1 (Truckee Library) of the Truckee Library Joint Powers Authority special election to be held on November 4, 2025; and

WHEREAS, the special election of the Community Facilities District No. 1 (Truckee Library) of the Truckee Joint Powers Authority (the "District") meets all the elements necessary to consolidate with the California Statewide Special Election; and

WHEREAS, the Community Facilities District No. 1 (Truckee Library) of the Truckee Joint Powers Authority, which includes both Nevada and Placer Counties, will also have this same bond tax measure appear on ballots administered in Placer County; and

WHEREAS, Elections Code section 10002 provides that a governing body of a district may request a County elections official to render election services, at a cost that shall be borne by the district, and that said election services shall be performed by the county elections official upon approval of the Board of Supervisors; and

WHEREAS, the Community Facilities District No. 1 (Truckee Library) of the Truckee Joint Powers Authority shall reimburse the County for its prorated share of costs incurred by the county elections official, in accordance with Elections Code section 10520, in addition to the costs already incurred prior to consolidation with the California Statewide Special Election.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Nevada County Clerk-Recorder-Registrar of Voters is directed to consolidate the Community Facilities District No. 1 (Truckee Library) of the Truckee Joint Powers Authority tax measure with the November 4, 2025 California Statewide Special Election, and to bill the District for its prorated share of costs incurred by the county elections official, in accordance with Elections Code section 10520, in addition to the costs already incurred prior to consolidation with the California Statewide Special Election.
