## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

**RESOLUTION APPROVING THE PROFESSIONAL SERVICES CONTRACT BETWEEN NEVADA COUNTY BEHAVIORAL HEALTH AND EVALCORP TO ASSIST IN THE COMMUNITY PLANNING PROCESS FOR THE BEHAVIORAL HEALTH SERVICES ACT (BHSA) INTEGRATED PLAN, COMPILE DATA, ASSIST WITH THE COMPLETION OF THE THREE-YEAR INTEGRATED PLAN, AND ADVISE ON THE DEVELOPMENT OF A REQUEST FOR PROPOSAL PROCESS FOR BHSA FUNDING DISTRIBUTION TO CONTRACTED PROVIDERS FOR THE CONTRACT TERM OF JULY 17, 2025 THROUGH JUNE 30, 2026, IN THE MAXIMUM AMOUNT OF \$132,700 AND DIRECTS THE AUDITOR-CONTROLLER TO AMEND THE BEHAVIORAL HEALTH BUDGET FOR FISCAL YEAR 2025/26 (4/5 AFFIRMATIVE VOTE REQUIRED)**

WHEREAS, the Mental Health Services Act (MHSA), adopted by the California electorate on November 2, 2004, created a new revenue source for the transformation and enhancement of public mental health services; and

WHEREAS, Proposition 1 passed in March 2024 replaces the MHSA with the Behavioral Health Services Act (BHSA); and

WHEREAS, the BHSA requires a comprehensive community planning process to inform County Behavioral Health programming and expenditures; and

WHEREAS, Nevada County Behavioral Health Department selected EVALCORP in a Request for Proposals process to facilitate the community planning process; and

WHEREAS, EVALCORP will conduct a community planning process, develop a needs assessment summary, advise the Request for Proposal process for County Behavioral Health Programming, and assist in the development of the Nevada County BHSA Integrated Plan for FY 26/27, 27/28, and 28/29.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State to assist in the Community Planning Process for the Behavioral Health Services Act Integrated Plan, compile data, assist with the completion of the Three-Year Integrated Plan, and advise on the development of a Request for Proposal process for BHSA funding distribution to contracted providers for the contract term of July 17, 2025 through June 30, 2026, in the maximum amount of \$132,700 be and hereby is approved, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the contract on behalf of the County of Nevada and directs the Auditor-Controller to release \$132,700 fund balance in Fund 1512 and amend Behavioral Health's budget as follows:
