**RESOLUTION APPROVING AMENDMENT NO. 1 TO THE CONTRACT BETWEEN THE COUNTY OF NEVADA AND HDR CONSTRUCTION CONTROL GROUP INC., FOR CONSTRUCTION MANAGEMENT AND INSPECTION SERVICES FOR THE HIRSCHDALE ROAD OVER TRUCKEE RIVER BRIDGE REPLACEMENT PROJECT, COUNTY PROJECT NUMBER 224029 AND THE HIRSCHDALE ROAD AT HINTON (UPRR) OVERHEAD REHABILITATION PROJECT, COUNTY PROJECT NUMBER 224030 - BRLO 05917 (092 & 097) – DISTRICT V**

WHEREAS, the County of Nevada approved a contract with HDR Construction Control Group Inc. on November 26, 2024, by Resolution 24-613 for services including Construction Management and Inspection, for the Hirschdale Road over Truckee River Bridge Replacement Project and Hirschdale Road at Hinton (UPRR) Overhead Rehabilitation Project; and

WHEREAS, Amendment No. 1 is to clarify a term of responsibility in the contract; and

WHEREAS, there is sufficient budget available in the Road Capital Improvement Fund 1114-30154-702-3000-540712 and a budget amendment is not necessary.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors approves Amendment No. 1, attached hereto, to the professional services contract by and between the County of Nevada and HDR Construction Control Group, Inc. and the Chair of the Board of Supervisors is hereby authorized to execute Amendment No. 1.

**AMENDMENT NO. 1 TO THE CONTRACT WITH  
HDR CONSTRUCTION CONTROL GROUP INC.**

THIS AMENDMENT is executed this 14th day of January 2025, by and between HDR CONSTRUCTION CONTROL GROUP, Inc., and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled "Design/Engineering Professional Services Contract" for the Construction Management and Inspection Services on the Hirschdale Road Truckee River and Hinton Overhead Bridge projects executed on November 26, 2024, by Resolution No. 24-613.

WHEREAS, the parties desire to amend the contract by adding the following language:

"48. Construction Procedures Consultant's observations or monitoring portions of the work performed under construction contracts shall not relieve the construction contractor from its responsibility for performing work in accordance with applicable contract documents. Consultant shall not control or have charge of, and shall not be responsible for, construction means, methods techniques, sequences, procedures of construction, health or safety programs or precautions connected with the work and shall not manage, supervise, control or have charge of construction. Consultant shall not be responsible for the acts of omissions of the construction contractor or other parties on the project. "

WHEREAS, this amendment shall be effective when signed by both parties.

NOW, THEREFORE, the parties hereto agree as follows:

1. The original scope of work is amended to include the language listed above.
2. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
