RESOLUTION AUTHORIZING THE DISTRICT ATTORNEY'S OFFICE TO SUBMIT A GRANT APPLICATION TO THE CALIFORNIA OFFICE OF EMERGENCY SERVICES FOR THE VIOLENCE AGAINST WOMEN VERTICAL PROSECUTION PROGRAM AND AUTHORIZING THE DISTRICT ATTORNEY AND/OR GRANT SUBAWARD AUTHORIZED AGENTS TO EXECUTE ALL REQUIRED GRANT DOCUMENTS

WHEREAS, the California Office of Emergency Services (Cal OES) provides funding through the Violence Against Women Vertical Prosecution Program to improve the criminal justice system's processing of violent crimes against women through a coordinated, multi-disciplinary, prosecutorial response to violent crimes against women; and

WHEREAS, the Nevada County District Attorney's Office intends to apply for the non-competitive funding under this program, grant number VV25022601, in the amount of \$202,545; and

WHEREAS, designated Grant Subaward Authorized Agents are authorized to initiate, review, and submit all necessary grant-related documents, including applications, amendments, modifications, expenditure reports, and progress reports; and

WHEREAS the Grant Subaward Authorized Agents for this program include the District Attorney, the Assistant District Attorney, and the Administrative Analysts.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Nevada, State of California, hereby authorizes the District Attorney's Office to submit a grant application to Cal OES for the Violence Against Women Vertical Prosecution Program in the amount of \$202,545, for the grant period of January 1, 2026, through December 31, 2026; and

BE IT FURTHER RESOLVED that the District Attorney, or their designee, and/or the designated Grant Subaward Authorized Agents are hereby authorized to execute all documents required to comply with and fulfill the grant requirements.

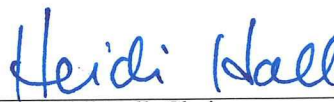
