

**NEVADA COUNTY BOARD OF SUPERVISORS  
IS SEEKING INTERESTED PERSONS TO SERVE ON THE FOLLOWING:**

**\*ADULT AND FAMILY SERVICES COMMISSION:** (4 vacancies) Two Public Sector vacancies, one to fill a 2-year unexpired term ending April 30, 2021 and the other to fill a 2-year unexpired term ending April 30, 2022; two Private Sector vacancies for 2-year terms ending April 30, 2022. This Commission shall operate under the Nevada County Board of Supervisors as the primary advisory body relative to health and human services' needs and performs the responsibilities of the Board of Directors as described under Title 42 USC Chapter 106 § 9910 - Tripartite Boards. Private Sector members shall represent labor, business, or other private business, industry, labor, religious, human services, education, or other major groups and interests in the community. **\*AREA 4 AGENCY ON AGING ADVISORY COUNCIL:** (2 vacancies) Two Board of Supervisors appointed representatives, one to fill an unexpired 3-year term ending June 30, 2023 and one to fill an unexpired 3-year term ending June 30, 2022. The Advisory Council shall advise the area agency on all matters relating to development and administration of the Area Plan and operations conducted thereunder. **\*ASSESSMENT APPEALS BOARD:** (1 vacancy) One alternate member to fill an unexpired 1-year term ending September 30, 2020. Specific qualifications are required per Section 1624 of the Revenue and Taxation Code. The function of the Appeals Board is to determine the full value of property or to determine other matters of property tax assessment over which the Appeals Board has jurisdiction. The Board acts in a quasi-judicial capacity and renders its decision only on the basis of proper evidence presented at the hearing. The functions of the Board are outlined in Section 1620 et seq. of the Revenue and Taxation Code. Compensated per Administrative Code Chapter II, Article 13.11. **\*CHILD CARE COORDINATING COUNCIL:** (5 positions) One Child Care Provider, one Community member, one Consumer member, one Discretionary member and one Chair of the Board of Supervisors Public Agency representative, all to fill two year terms beginning June 30, 2020. The purpose of this council shall be to identify child care and development services' priorities to enhance cooperation among children's services, interest groups and agencies, develop a strategic long-range plan for a broad spectrum of child care and development services, and advocate the support of child care and development services at the local, state and federal levels of government. **CITIZENS' OVERSIGHT COMMITTEE OF THE NEVADA COUNTY LIBRARY:**

(1 position) One public representative position available June 30, 2020 for a 4-yr term ending June 30, 2024. To ensure that the Eastern and Western Nevada County libraries are receiving equitable amounts of the Nevada County Library Fund and operate in accordance with the Nevada County Library Strategic Plan, residents from Eastern County are encouraged to apply. This Committee reviews, advises, and monitors the library's revenues, expenditures, and services. The goals of this committee are 1) to ensure that the County of Nevada receives all library tax monies collected by the Board of Equalization and that those monies are placed in the Nevada County Library Fund; 2) to ensure that the county of Nevada annually transfers its maintenance and effort funds, under the provisions of state laws, to the Nevada County Library Fund; 3) to ensure that the Eastern and Western Nevada County libraries are receiving equitable amounts of the Nevada County Library Fund and operate in accordance with the Nevada County Library Strategic Plan; 4) to review and advise the County Librarian on the Strategic Plan and the annual County Library Budget; and 5) to facilitate the free flow of regular communication between the Committee and all interested library patrons and organizations.
