# PURPOSE & RESPONSIBILITY

- ANNUALLY REVIEW THE AMBULANCE SERVICES OPERATING WITHIN THE COUNTY
- ANNUALLY REVIEW EMERGENCY MEDICAL CARE OFFERED WITHIN THE COUNTY INCLUDING PROGRAMS FOR TRAINING PEOPLE IN CARDIOPULMONARY RESUSCITATION AND LIFESAVING FIRST AID TECHNIQUES
- ANNUALLY REVIEW FIRST AID PRACTICES WITHIN THE COUNTY
- ANNUALLY REPORT ITS OBSERVATIONS AND RECOMMENDATIONS TO THE BOARD OF SUPERVISORS AND THE LOCAL EMS AGENCY (SIERRA-SACRAMENTO VALLEY EMERGENCY MEDICAL SERVICES AGENCY)
- ANNUALLY APPOINT A MEMBER FROM THE EMCC TO SERVE ON THE MEDICAL CARE COMMITTEE OF THE LOCAL EMS AGENCY
- REVIEW AND COMMENT ON PROPOSED EMS LEGISLATION, EMS PLANS, PROTOCOLS AND POLICIES TO BE ADOPTED BY THE LOCAL EMS AGENCY
