OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING ACCEPTANCE OF PROPOSITION 36 GRANT AWARD AND EXECUTION OF A SUBRECIPIENT AGREEMENT WITH SIERRA HEALTH FOUNDATION- CENTER FOR HEALTH PROGRAM MANAGEMENT ON BEHALF OF THE CALIFORNIA DEPARTMENT OF HEALTH CARE SERVICES (DHCS) IN THE MAXIMUM AMOUNT OF \$334,342.14 FOR THE CONTRACT TERM OF MARCH 1, 2026 THROUGH MARCH 31, 2028 AND AUTHORIZING AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE BEHAVIORAL HEALTH DEPARTMENT'S BUDGET FOR FISCAL YEAR 2026/27 (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, Proposition 36, also known as the Community Based Substance Use Treatment Expansion, was approved by voters in November 2024, and modified provisions of Proposition 47 to increase accountability for certain drug and theft crimes and allow for mandated substance use treatment for individuals with repeat drug offenses; and

WHEREAS, the Department of Health Care Services (DHCS) through Assembly Bill 102, has made available grant funding to counties for the implementation of Proposition 36 program requirements; and

WHEREAS, Proposition 36 grant funding is one time funding for counties to support the planning, capacity, building, and treatment services related to community-based substance use treatment requirements under Prop 36; and

WHEREAS, Nevada County was awarded grant funding to support the implementation of Proposition 36 within the county behavioral health system; and

WHEREAS, DHCS has contracted with Sierra Health Foundation- Center for Health Program Management for the administration of grant funding.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Subrecipient Agreement by and between the County and Sierra Health Foundation: Center for Health Program Management pertaining to the implementation of Proposition 36 court mandated substance use treatment services for the contract term of March 1, 2026 through March 31, 2028, in the maximum amount of \$334,342.14 be and hereby is approved, and that the Director of Behavioral Health be and is hereby authorized to execute the Agreement on behalf of the County of Nevada and that the Chair of the Board of Supervisors authorizes and directs the Auditor-Controller to amend Behavioral Health's Fiscal Year 2026/27 budget as follows:
