RESOLUTION ACCEPTING THE CAL OES EMERGING FAMILY JUSTICE CENTER GRANT AWARD FE24022601 IN THE AMOUNT OF \$210,305 FOR THE PERIOD OF OCTOBER 1, 2024, THROUGH MARCH 31, 2026, AND AUTHORIZING THE DISTRICT ATTORNEY, OR THEIR ASSIGNEE, TO EXECUTE THE GRANT AGREEMENT AND ALL ADDITIONAL DOCUMENTS TO FULFILL THE GRANT REQUIREMENTS AND DIRECTING THE AUDITOR CONTROLLER TO AMEND THE FISCAL YEAR 2024/25 BUDGET (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the California Office of Emergency Services (Cal OES) has awarded the County of Nevada District Attorney's Office State General Funds (FJC0) in the amount of \$210,305 for the Emerging Family Justice Center (FE) program; and

WHEREAS, the FE Program supports and provides legal services to victims of domestic violence, intimate partner violence, sexual assault, child abuse, elder abuse, transnational abandonment, and human trafficking, and to help victims file petitions for protective orders, including domestic violence restraining orders and gun violence restraining orders; and

WHEREAS, victim/survivors of intimate partner violence in Nevada County face several barriers to accessing services, to include geographic isolation and transportation barriers, demonstrating a need for the services that would be provided by this Family Justice Center Program; and


WHEREAS, professionals within the Nevada County service provider community have long-identified the need for a centralized victim-services center and have recently mobilized in order to implement the vision; and

WHEREAS, funds from this program, would support our County in establishing and staffing a multidisciplinary Family Justice Center.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors of the County of Nevada, State of California, hereby approves and resolution accepting the Cal OES Emerging Family Justice Center (FE) Grant award in the amount of \$210,305 for the period of October 1, 2024, through March 31, 2026, and authorizing the District Attorney or their assignee, to execute the grant agreement and all additional documents to fulfill the grant requirements.

BE IT FURTHER RESOLVED that the District Attorney is directing the Auditor Controller to amend the fiscal year 2024/25 budget as follows:
