The primary function of the Housing Authority is to assist low and moderate-income families, including elderly and handicapped persons, by operating programs that provide decent, safe and sanitary housing at affordable costs. The area of jurisdiction of the Housing Authority is the entire Counties of Sutter and Nevada.

A board of nine Commissioners directs the Housing Authority. The governing body of the Regional Housing Authority shall be referred to as the Board of Commissioners and shall consist of; two (2) persons appointed by the Nevada County Board of Supervisors, two (2) persons appointed by the Sutter County Board of Supervisors, two (2) persons appointed by the governing body of the City of Live Oak, two (2) persons appointed by the governing body of the City of Yuba City; and except as otherwise provided in Section 34246.5, one Tenant Commissioner of the Housing Authority as appointed jointly by the governing bodies of the Cities of Live Oak and Yuba City and the Board of Supervisors of the Counties of Sutter and Nevada upon the recommendation of the Regional Housing Authority Board of Commissioners. The member governing bodies shall notify the Secretary of the Housing Authority, in writing, of all appointment.
