**PETITION FOR VESTED RIGHTS:** Public Hearing to consider the request of Braiden Chadwick, Mitchell Chadwick, LLP, on behalf of Benjamin Mossman, Rise Grass Valley, Inc. for a formal determination by the County of Nevada concerning the possible existence and scope of vested mining rights to mine the 175.64-acre subject properties and associated mineral rights.
