Transportation Development Act, Title 3, Division 3, Chapter 2 of State Government Code Section 29535 established Commission in 1971 and became effective in 1972. Statutorily designated as the Transportation Planning Agency for Nevada County in 1996 pursuant to Government Code Section 29532.1. Nevada County Transportation Authority - Res. 89-245 May 20, 2003 Board of Supervisors Meeting (Membership designation); Res. 10-113 designating the NCTC as the Airport Land Use Commission for the Nevada County Airport.

This Commission functions as a Regional Transportation Planning Agency to develop and endorse a Regional Transportation Plan (RTP), a Regional Transportation Improvement Program (RTIP), and to administer the requirements of the Transportation Development Act (TDA). It also directs the administration of the TDA funds received in Nevada County.

Pursuant to Gov. Code 67920, membership shall consist of seven members. The Board of Supervisors appoints four members; two are elected supervisors appointed by the Board Chair and two are at-large members with one from the elderly/disabled community. The City Council from each incorporated city in the County appoints one member. At-large appointments shall be for four-year terms. The appointing authority, for each regular member it appoints, may appoint an alternate member to serve in place of the regular member when the regular member is absent or disqualified from participating in a meeting of the agency.

Pursuant to County Resolution 10-113, the members of the Nevada County Transportation Commission shall serve as the Nevada County Airport Land Use Commission.

Meetings are held third Wednesday of every other month as announced.
