



# RESOLUTION No. 17-203

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION APPROVING RENEWAL AGREEMENT WITH CALIFORNIA STATE ASSOCIATION OF COUNTIES-EXCESS INSURANCE AUTHORITY (CSAC-EIA) DISABILITY PROGRAM, AS AMENDED PER RESOLUTION 14-297, FOR SHORT-TERM AND LONG-TERM DISABILITY INSURANCE THROUGH RELIASTAR ING (ING) FOR THE PERIOD 7.1.17 TO 6.30.20

WHEREAS, this resolution sets the rate for Short-Term Disability (STD) at \$.208/\$10 of covered earnings, and further sets the rate for Long-Term Disability (LTD) at \$.473/\$100 of covered earnings, each for the period of July 1, 2017 through June 30, 2020; and

WHEREAS, the previous STD rate was \$.208/\$10 of covered earnings, and for LTD was \$.473/\$100 of covered earnings, each covering the period of July 1, 2014 through June 30, 2017; and

BE IT HEREBY RESOLVED by the Board of Supervisors, of the County of Nevada, State of California, that the Renewal Agreement between the County of Nevada and the California State Association of Counties-Excess Insurance Authority Disability Program for the provision of short-term disability (STD) insurance for employees in Department Head and County Executive Officer positions; and long-term disability (LTD) insurance for employees in the positions of Department Head and County Executive Officer, the correctional officer series, and the probation officer series be and hereby is approved, and that the Chair of the Board of Supervisors is hereby authorized to execute the Renewal Agreement on behalf of the County of Nevada.

Benefit charges will be collected and expensed through payroll clearing fund 9901, liability account code 292263.
