RESOLUTION ACCEPTING THE CALIFORNIA OFFICE OF EMERGENCY SERVICES GRANT AWARD VW24022601 FOR THE NEVADA COUNTY VICTIM WITNESS ASSISTANCE PROGRAM IN THE AMOUNT OF \$368,865.00 FOR THE PERIOD OF OCTOBER 1, 2024, THROUGH SEPTEMBER 30, 2025, AND AUTHORIZING THE DISTRICT ATTORNEY, OR THEIR ASSIGNEE, TO EXECUTE THE GRANT AGREEMENT AND ALL ADDITIONAL DOCUMENTS TO FULFILL THE GRANT REQUIREMENTS AND DIRECTING THE AUDITOR CONTROLLER TO AMEND THE FISCAL YEAR 2024/25 BUDGET (4/5/AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the California Office of Emergency Services (Cal OES) has awarded the County of Nevada District Attorney's Office State Victim Witness Assistance Grant Funds (VWAO), Victims of Crime General Funds (VCGF) and Federal Victim of Crime Act (VOCA) Grant funds; and

WHEREAS, the Cal OES grant award is comprised of State VWAO funds in the amount of \$34,064, State VCGF funds in the amount of \$150,454, and Federal VOCA funds in the amount of \$184,347 for a total of \$368,865, and have been made available for the grant period of October 1, 2024, to September 30, 2025; and

WHEREAS, these funds will be used to provide services to victims and witnesses of crime as specified in California Penal Code sections 13835-13835.5, including crisis intervention and other comprehensive services for the victims and witnesses of crime in Nevada County.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Nevada, State of California, hereby accepts the California Office of Emergency Services grant for the Nevada County Victim/Witness Assistance Program in the amount of \$368,865, for the grant period of October 1, 2024, through September 30, 2025, and authorizes the District Attorney, or their designee to execute any additional documents, including extensions or amendments thereto, required by Cal OES and necessary for implementation of this grant award.
