SUBJECT: Resolution approving execution of a contract with Sierra Nevada

Memorial Hospital Foundation for creation of a Nevada County

HealthSpan community wellness initiative in the maximum contract price of \$300,000 for the term of November 1, 2025, to June 30, 2028 and authorizing and directing the Auditor-Controller to amend the Public Health Budget for Fiscal Year 2025/26. (4/5 Affirmative Vote Required)

RECOMMENDATION: Approve the attached Resolution.

<u>FUNDING</u>: This agreement is funded with HHSA Intergovernmental Transfer Funds through Public Health's Accreditation subservice. A budget amendment is required and is included in this Resolution. There are no county general fund dollars required in the agreement.

BACKGROUND: The primary goals of the HealthSpan Project include enhancing community health outcomes, reducing the prevalence of chronic diseases in the region, and alleviating the burden on the region's already strained healthcare system. By identifying and elevating effective health and wellness programs, HealthSpan helps ensure that proven strategies receive the attention and resources they need to make a broader impact.

The Contractor shall create and develop the HealthSpan Project to implement a community wellness initiative in Nevada County. The Contractor shall focus a program around the pillars of Food, Movement, Social Connections, and Youth and Families. The Contractor shall maintain a steering committee for the project including the Hospital, County, and Community Stakeholders. The Contractor will utilize existing County data and plans, including the Community Health Assessment (CHA) and Community Health Improvement Plan (CHIP), and will coordinate with Nevada County Public Health and other Health and Human Services Agency departments when collecting any additional data. The Contractor will share draft and final materials, findings, and results with Nevada County and the Board of Supervisors and will align recommendations with existing County priorities. The Contractor will also recognize that the County already has several

active community health coalitions, task forces, steering committees, and collaboratives. Whenever possible, HealthSpan activities should be integrated into these existing groups rather than creating new, duplicative structures. The Contractor will obtain County concurrence before initiating any activities that could overlap with existing programs or resources. The Contractor will foster cross-sector partnerships, ensuring that knowledge, expertise, and
