## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

### **RESOLUTION APPROVING THE COOPERATIVE AGREEMENT NO. 18-0661-00-SG BETWEEN THE COUNTY OF NEVADA AND THE CALIFORNIA DEPARTMENT OF FOOD AND AGRICULTURE (CDFA) FOR COSTS INCURRED IN CONTROLLING INVASIVE AND NOXIOUS WEEDS FOR THE PERIOD JUNE 30, 2019, THROUGH MARCH 31, 2021, IN AN AMOUNT NOT TO EXCEED \$42,874.19 AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE AGREEMENT**

WHEREAS, the destructive impact of invasive and noxious weeds is profound, affecting Nevada County's cropland, rangeland, forests, parks, waterways, and wildlands; and

WHEREAS, these pests result in losses of private, State, and Federal resources through decreased land productivity, decreased water supply, degradation of wildlife habitat, and outright destruction of crops, livestock range, wetlands, waterways, watersheds, and recreation areas; and

WHEREAS, the Nevada County Agricultural Commissioner's Office has a long-standing history of controlling invasive and noxious weeds; and

WHEREAS, the CDFA will reimburse the County for its efforts in controlling these invasive and noxious weeds as outlined in the agreement's project narrative; and

WHEREAS, funds when received will be deposited into the Agricultural Commissioners budget code 0101-20601-301-1000/441530.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada that:

1. The foregoing recitals are adopted as findings of the Board of Supervisors as set forth fully herein.
2. The Board of Supervisors approves Cooperative Service Agreement Number 18-0661-000-SG between the County of Nevada and the CDFA from June 30, 2019, through March 31, 2021, and authorizes the Chair of the Board of Supervisors to Execute the Agreement.
3. The Board of Supervisors hereby finds and determines that approval of this Resolution is pursuant to the attached California Environmental Quality Act document.
4. The Agricultural Commissioner is hereby directed to file the attached CEQA document with the County Clerk of the County of Nevada within 24 hours after the adoption of this Resolution.
5. The County Clerk is hereby directed upon receipt of attached CEQA document, to post the attached document according to CEQA Guideline §15062.
