



# RESOLUTION No. 22-390

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION ADOPTING THE CERTIFIED STATEMENT OF VOTES CAST AT THE CALIFORNIA STATEWIDE DIRECT PRIMARY ELECTION HELD ON JUNE 7, 2022 IN THE COUNTY OF NEVADA AS CERTIFIED BY THE COUNTY CLERK-RECORDER/REGISTRAR OF VOTERS.

WHEREAS, California Elections Code § 15372 requires the Nevada County Clerk-Recorder/Registrar of Voters to prepare a certified statement of election results within the county and submit it to the Board of Supervisors; and

WHEREAS, the Nevada County Clerk-Recorder/Registrar of Voters did canvass the returns of the June 7, 2022 California Statewide Direct Primary Election, and has certified the results of the votes cast at said election, which are attached as Exhibit A and incorporated by reference; and

WHEREAS California Elections Code § 15400 provides that the Board of Supervisors shall declare elected to each office voted on at each election under its jurisdiction the person who receives a majority of all ballots cast for candidates for that office and shall also declare the results of each election under its jurisdiction as to each measure voted on at the election.
