OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION AUTHORIZING THE EXECUTION OF AMENDMENT NO. 1 TO THE PERSONAL SERVICES CONTRACT WITH CALIFORNIA FORNESCIC MEDICAL GROUP, INC. FOR MEDICAL, MENTAL HEALTH AND DENTAL SERVICES AT THE ADULT CORRECTIONAL FACILITIES IN NEVADA COUNTY, AMENDING EXHIBIT A TO ALLOW CFMG TO HIRE LICENSED VOCATIONAL NURSES (LVNS) AND INCREASES THE CONTRACT BY \$171,503 FOR A TOTAL NOT TO EXCEED AMOUNT OF \$13,899,671

WHEREAS, one of the mandated responsibilities of the Nevada County Sheriff's Office is to provide correctional services for the County and provide inmates with medical, mental health and dental care pursuant to Title 15 of the California Code of Regulations; and

WHEREAS, the California Forensic Medical Group, Inc. (CFMG) has been the County's provider of medical, mental health and dental care in its correctional facilities for years and in 2020 entered into a new contract with CFMG beginning January 1, 2021 through July 30, 2024 (Resolution 20-508); and

WHEREAS, associated contract costs and the standard for level of care and hours of medical, mental health and dental services provided have increased, along with costs in general having increased; and

WHEREAS, the CFMG Registered Nurse (RN) staffing positions have been difficult to fill and modifying the contract to allow for employment of Licensed Vocational Nurses (LVNs) as an option will allow CFMG to more readily achieve desired staffing levels to provide medical care to incarcerated persons; and

WHEREAS, the Sheriff's Office and CFMG desire to amend the contract for the period of January 1, 2021 through June 30, 2024 to increase the maximum contract amount by \$171,503 to a total not exceed amount of \$13,899,671.00, with a continued two (2) 2-year options to renew.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors, of the County of Nevada, State of California, that the Chair of the Board of Supervisors be and is hereby authorized to execute, on behalf of the County of Nevada, Amendment No. 1 to the personal services contract with the California Forensic Medical Group Inc., entitled Medical, Mental Health and Dental Services for the Adult Correctional Facilities in Nevada County, amending Exhibit A to permit CMFG to hire LVNs and revises the contract total not to exceed amount to \$13,899,671 as detailed in Amendment No. 1 to the Contract.
