



RESOLUTION No. 25-464

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING A BUDGET AMENDMENT FOR THE INFORMATION AND GENERAL SERVICES ADMINISTRATION FISCAL YEAR 2025/26 BUDGET FOR THE MOU APPROVED BY RESOLUTION 25-095 IN THE AMOUNT OF \$54,000 BETWEEN THE COUNTY OF NEVADA AND THE CITY OF GRASS VALLEY FOR REIMBURSEMENT OF TABLET COMMAND SOFTWARE (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the Grass Valley Fire Department requires a software platform that provides mapping, automatic vehicle location, mobile data terminal, and other capabilities for optimal performance of its fire services; and

WHEREAS, the current platform utilized by the Fire Department and the majority of fire agencies in Nevada County will be discontinued and inoperable in March; and

WHEREAS, the software program from Tablet Command, Inc (“Tablet Command”) has been identified as the optimal replacement due to its functionality enhancements and improvements to interoperability among all fire agencies in Nevada County; and

WHEREAS, the Office of Emergency Services has met with relevant stakeholders and determined that the purchase and implementation of Tablet Command will strengthen emergency response capabilities; and

WHEREAS, the Office of Emergency Services has further identified that purchase and implementation of Tablet Command is in alignment with the allowable uses of Forest Reserve Title III funds and is concurrently bringing to the Board of Supervisors a proposed Title III spend plan for this purpose; and

WHEREAS, the Secure Rural Schools and Community Self-Determination Act of 2000 requires that the Nevada County Board of Supervisors hold a 45-day public comment period, hold a public hearing, and approve a spending plan for Title III funds; and

WHEREAS, the public hearing was held on May 27, 2025; and

WHEREAS, The Board of Supervisors previously approved Resolution 25-095 on March 11, 2025, authorizing funding for Tablet Command Software; and

WHEREAS, the funds authorized under the prior resolution were not encumbered before the end of the fiscal year, and as a result this resolution requests the funding for Fiscal Year 2025/26 to proceed with the intended project or purpose.

NOW, THEREFORE, BE IT RESOLVED by a four-fifths affirmative vote of the Board of Supervisors of the County of Nevada, that the Auditor-Controller is directed to release fund balance from the Forest Reserve Budget and amend the Forest Reserve Fiscal Year 2025/26 Budget for the MOU spending agreement with the City of Grass Valley in the amount of \$54,000 as previously approved by Resolution 25-195 as follows:
