SUBJECT: (Waiver Further Reading/Adopt) An Ordinance revising Sections of the Nevada County Land Use Code

RECOMMENDATION: The proposed Ordinance was introduced at the October 10, 2023 Board of Supervisor meeting. It is now recommended to waive further reading and adopt the proposed Ordinance.

FUNDING: The revision will have no fiscal effect.

BACKGROUND:

The Codes of the County of Nevada were last fully updated in 2006 by Ordinance No. 2192. In an effort to create uniformity in internal referencing; language usage; updated pronouns; Agency and Departmental organization; as well as to verify accuracy of citation and comport with California state statutes, County Counsel's Office has been working with County agencies and departments and proposes the following revisions.

Therefore, it is recommended that the Board adopt this proposed Ordinance to:

Revise:

Chapter I: "General Provisions" of the Nevada County Land Use Code is hereby revised and amended to read as shown in "Exhibit A" attached hereto and incorporated by reference.
