
WHEREAS, this amendment is executed this 10th day of January, 2017 by and between Riitta Herwitz Design Support LLC ("Herwitz") and the County of Nevada. Said Amendment will amend the prior agreement between the parties entitled Resolution Approving a Renewal Contract between the County of Nevada and Riitta Herwitz Design Support LLC Authorizing Execution of a Three-Year Agreement with Herwitz for Recruitment Advertising Services executed on June 28, 2016, by Resolution 16-315; and

WHEREAS, the parties desire to amend their agreement to update the method of payment in the schedule of charges; and

WHEREAS, the correction fixes a previously contemplated payment arrangement and is budget-neutral with respect to the maximum contract price.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors:

1. Approves Amendment One to Contract with Riitta Herwitz Design Support LLC found in Exhibit A, attached, and authorizes the Chair of the Board of Supervisors to execute the amended Contract.

EXHIBIT A

Amendment One to Contract with Riitta Herwitz Design Support LLC (Resolution 16-315) **Dated June 28, 2016**

- 1. This amendment shall be effective as of October 1, 2016
- 2. That the Schedule of Charges and Payments, Exhibit "B," shall be amended by adding the following:
 - 1. The fees for services provided to the County of Nevada pursuant to this Agreement will be calculated and billed at the following rates:

Non-commissionable media: 15% of cost of advertising

Commissionable media: Media pays advertiser directly

Non-commissionable web sites: \$125 per web posting or print ad placement, plus cost of advertising.

- 2. The contractor will send the County of Nevada statements for each ad run and the costs incurred for the ad. Each statement will be payable within 30 days of its date. Invoices must be paid within 30 days.
- 3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
