RESOLUTION AUTHORIZING EXECUTION OF A RENEWAL AND AMENDMENT NO. 1 TO THE PERSONAL SERVICES CONTRACT BMC15192 WITH IMPACT CONSTRUCTION SERVICES, INC., PERTAINING TO THE PURCHASE AND INSTALLATION OF A MODULAR BUILDING FOR THE NEVADA COUNTY CRISIS STABILIZATION UNIT (CSU) AT THE SIERRA NEVADA MEMORIAL-MINERS HOSPITAL (SNMH) CAMPUS, RESOLUTION 15-192, IN THE AMOUNT OF \$437,801 FOR THE PURPOSE OF EXTENDING THE TERM OF THE CONTRACT THROUGH JUNE 30, 2016

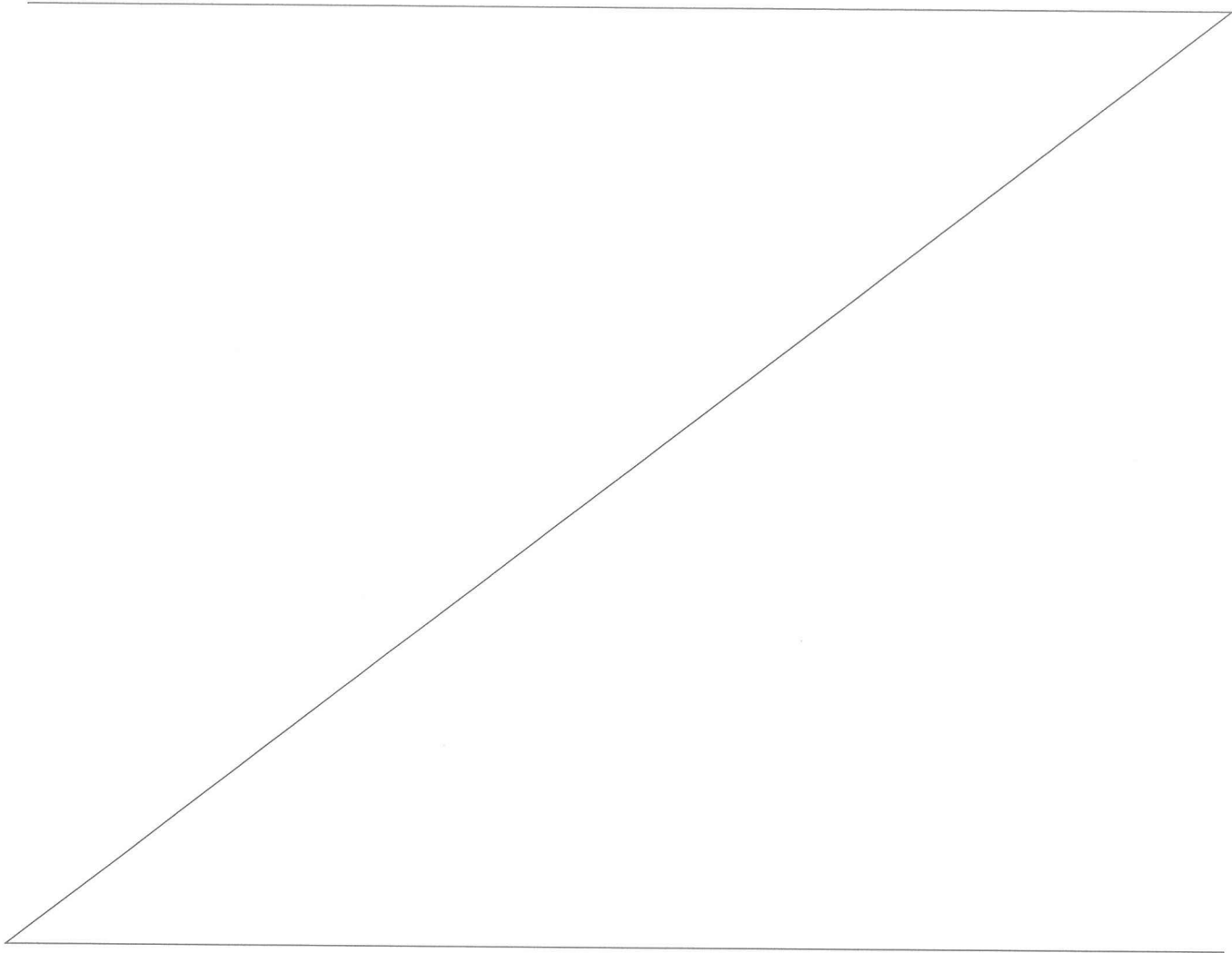
WHEREAS, through Resolution 15-192 a Contract was awarded to Impact Construction Services, Inc., for the project known as the Nevada County Crisis Stabilization Unit Modular Building; and

WHEREAS, unanticipated delays due to Americans with Disabilities Act (ADA) upgrades, code compliance and weather delays will require additional time to comply with the current term of the Contract that expired October 31, 2015; and

WHEREAS, both parties desire to renew and amend their agreement to provide for the additional time to comply with these requests and obtain the required permits; and

WHEREAS, that in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Board of Supervisors hereby approves in the form attached hereto, the Renewal and Amendment No. 1 to the Personal Services Contract BMC15192 between the County of Nevada and Impact Construction Services, Inc., pertaining to the purchase and installation of a modular building for the Behavioral Health CSU located at the SNMH in the amount of \$437,801 for the purpose of extending the term of the contract to a new term of May 12, 2015 through June 30, 2016. The Chair of the Board is hereby authorized to execute Amendment No. 1 on behalf of the County of Nevada.

AMENDMENT NO. 1 TO CONTRACT BMC15192 WITH IMPACT CONSTRUCTION SERVICES, INC.

THIS RENEWAL and AMENDMENT is executed this 12th day of January, 2016 by and between Impact Construction Services, Inc., (herein "Contractor") and COUNTY OF NEVADA (herein "County"). Said Amendment will renew and amend the prior Agreement between the parties entitled "Nevada County Crisis Stabilization Unit Modular Building" executed on May 12, 2015.

WHEREAS, the contract was executed between the County and Contractor to provide and install a modular building for the Nevada County Crisis Stabilization Unit at the Sierra Nevada Memorial Hospital campus and was effective for the period May 12, 2015 through October 31, 2015; and

WHEREAS, unanticipated delays due to expanded ADA improvements, code compliance and weather delays will require additional time to bring the modular building into compliance; and

WHEREAS, both parties desire to renew and amend their agreement to provide for the additional time to comply with these requests and obtain the required permits.

NOW THEREFORE, the parties hereto agree as follows:

1. That the new term of the contract shall be May 12, 2015 through June 30, 2016.
2. That in all other respects the prior Agreement of the parties shall remain in full force and effect except as amended herein.
