**SUBJECT:** Designation of the 2020 Board members to serve as delegate and alternate to the Rural County Representatives of California (RCRC); the Golden State Finance Authority; and the Rural Counties Environmental Services Joint Powers Authority.

**BACKGROUND:**

At the beginning of each year, after the new Chair has been appointed, the Chair reviews and makes changes to the list of his or her appointments to various committees/commissions, including the delegate and alternate to the Rural County Representatives of California (RCRC), the Golden State Finance Authority (GSFA) and the Rural Counties Environmental Services Joint Powers Authority (ESJPA).

The recommended appointments are discussed and acknowledged by the Board as one agenda item during a Board meeting. As of this writing, the committee/commission appointments have not been agendaized. However, RCRC will hold its first Board meeting on January 15th, 2020 and thus has requested its member Counties confirm their delegates and alternates prior to that date.

Supervisor Dan Miller has indicated his desire to continue to serve as delegate, and Supervisor Sue Hoek wishes to continue to serve as alternate.

Therefore, we request the Chair select, and the Board ratify, Supervisor Dan Miller to serve as delegate and Supervisor Sue Hoek to serve as alternate to the Rural County Representatives of California, the Golden State Finance Authority Board of Directors and the Rural Counties Environmental Services Joint Powers Authority.
