# Community Corrections Partnership (CCP)





# History

CCPs were established in Senate Bill 678 in 2009. It was the precursor to 2011 realignment legislation.

SB 678 program had two purposes: alleviating state prison overcrowding and saving state monies. These purposes are to be accomplished without compromising public safety by reducing the number of individuals on felony supervision who are sent to state prison. The program is also designed to encourage county probation departments to use evidence-based supervision practices to accomplish these goals.





# History Cont...

In 2011, Governor Brown signed into law Assembly Bill (AB) 109 and AB 117, hereafter referred to as Realignment, which made "fundamental changes to California's correctional system to stop the costly, ineffective and unsafe "revolving door" of lowerlevel offenders and parole violators through our state prisons" (excerpt from Governor's Press Release, April 5, 2011).





History Cont...

As a result, in the first six months of Realignment, over 38,000 individuals who would have been supervised by the State in prisons or on parole prior to these changes were instead being supervised and housed in jails by local county probation and sheriff departments. To respond to these changes, localities have created collaborative decision making bodies known as Community Corrections Partnerships (CCPs), chaired by the county Probation Chief.




#### **Adult Recidivism Definition**
