## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF A MEMORANDUM OF UNDERSTANDING (MOU) AGREEMENT 16-6051 BETWEEN THE CALIFORNIA DEPARTMENT OF SOCIAL SERVICES AND THE CALIFORNIA DEPARTMENT OF HEALTH CARE SERVICES, AS THE COMPACT ADMINISTRATOR AND COMPACT CO-ADMINISTRATOR, AND THE COUNTY OF NEVADA FOR THE PURPOSE OF AUTHORIZING COUNTY ACCESS TO THE ASSOCIATION OF ADMINISTRATORS OF THE INTERSTATE COMPACT ON ADOPTION AND MEDICAL ASSISTANCE (AAICAMA) DATABASE


WHEREAS, Pursuant to the authority granted by California Welfare and Institutions Code (WIC) Section 16121.2 and Sections 16170-16175, California is a member of the Interstate Compact on Adoption and Medical Assistance (ICAMA); and

WHEREAS, the California Department of Social Services (CDSS) and the California Department of Health Care Services (DHCS), as the Compact Administrator and Compact Co-Administrator respectively, have entered into a Memorandum of Understanding with the Association of Administrators of the Interstate Compact on Adoption and Medical Assistance (AAICAMA) for the implementation of a cloud based database, and this AAICAMA database replaces the paper ICAMA 700 form used to open Medicaid cases between states for adopted special needs children; and

WHEREAS, the purpose of this Memorandum of Understanding is to outline the terms and conditions for CDSS and DHCS to work with Counties of California for the implementation and utilization of the AAICAMA database, and authorizes County access to the AAICAMA database to permit the transfer of information between states for establishment of medical benefits for children with adoption assistance agreements through the AAICAMA database; and

WHEREAS, access to the database will save money through improved administrative efficiency in interstate case processing, and improve outcomes for children and families by reducing delays in Medicaid receipt, establishing uniform processes, and promoting stable permanency.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Memorandum of Understanding between by and between County and the California Department of Social Services and the California Department of Health Care Services, as the Compact Administrator and Compact Co-Administrator, for the purpose of authorizing County access to the Association of Administrators of the Interstate Compact on Adoption and Medical Assistance (AAICAMA) Database for the term of one year, commencing on the effective date (when signed by all parties) and automatically renewing for successive one-year terms unless terminated by any party, be and hereby is approved, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the MOU on behalf of the County of Nevada.
