BACKGROUND:

This project consists of placing an oil and rock chip surface, as well as minor roadside maintenance of ditches and shoulders, on approximately 20.96 miles of various County-maintained roads. This Department has reviewed the project as to compliance with the California Environmental Quality Act (CEQA) and has identified the project as a Class 1 and Class 4 project. Class 1 projects consist of repair or minor alteration of an existing public facility involving negligible or no expansion of use and Class 4 projects consists of minor public or private alterations in the condition of land, water, and/or vegetation which do not involve removal of healthy, mature, scenic trees except for forestry and agricultural purposes. Therefore, the project is categorically exempt from the provisions of CEQA, per Section 15301 (c) and 15304 (h) of the State CEQA Guidelines. A Notice of Exemption has been prepared for the project and upon approval by the Nevada County Board of Supervisors, will be filed with the Nevada County Clerk's Office.
