OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION AUTHORIZATION TO TRANSFER 2011 REALIGNMENT FUNDS FROM THE BEHAVIORAL HEALTH SUBACCOUNT TO THE PROTECTIVE SERVICES SUBACCOUNT AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE BEHAVIORAL HEALTH AND SOCIAL SERVICES BUDGETS FOR FISCAL YEAR 2025/26 (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the State of California established the Local Revenue Fund 2011 pursuant to Government Code §30025, including subaccounts for Behavioral Health and Protective Services, and Government Code §30025 through §30029.12 established the framework for administration and allocation of 2011 Realignment funding to counties for designated public health, behavioral health, and human services programs; and

WHEREAS, the County is responsible for administering Child Welfare Services pursuant to Welfare and Institutions Code §16500 et seq., Adult Protective Services pursuant to Welfare and Institutions Code §15600 et seq., and Behavioral Health services pursuant to Welfare and Institutions Code §5600 et seq.; and

WHEREAS, Government Code §30025 (f)(4)(A) authorizes counties to reallocate certain Local Revenue Fund 2011 monies up to 10 percent annually between specified subaccounts, provided that the reallocation may not exceed 10 percent of the amount deposited in the immediately preceding fiscal year in the subaccount in the Support Services Account with the lowest balance among local health and welfare trust fund accounts and following approval at a publicly noticed meeting of the governing body; and

WHEREAS, the County has identified a critical funding need within the Protective Services Subaccount to support mandated programs including, but not limited to, Child Welfare Services and Adult Protective Services; and

WHEREAS, the County has determined that sufficient fund balance exists within the Behavioral Health Subaccount to support a lawful transfer without impairing Behavioral Health program operations or violating maintenance of effort requirements; and

WHEREAS, the Board of Supervisors finds that the proposed transfer is consistent with Government Code §30025, supports the continued administration of state-mandated services, and is in the best interest of the County and its residents.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, hereby authorizes the transfer of up to \$523,265 depending on need and actual revenues received from the Behavioral Health Subaccount to the Protective Services Subaccount within the Local Revenue Fund 2011.

BE IT FURTHER RESOLVED that the Auditor Controller is directed to record the transfer and make all necessary accounting entries consistent with Government Code §30025 and related state guidelines.

BE IT FURTHER RESOLVED that County staff are authorized and directed to submit all required notifications, reports, and documentation to the State Controller's Office, the Department of Finance, and any other applicable state departments consistent with state law and guidance governing 2011 Realignment transfers.

BE IT FURTHER RESOLVED that the Auditor-Controller is authorized and directed to amend the Behavioral Health Department and Social Services Department Budgets for the Fiscal Year 25/26 as follows:
