OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION DESIGNATING THE EAGLE HOSE COMPANY SITE, LOCATED AT 139 EAST MAIN STREET, GRASS VALLEY, CA 95945 (APN 008-348-002), AS NEVADA COUNTY HISTORICAL LANDMARK NEV 25-09

WHEREAS, the Nevada County Historical Landmarks Commission (NCHLC) was established in 1969 to promote the general welfare of Nevada County and its citizens through official recognition, recording, marking, preserving, and promoting the historical resources of Nevada County; and

WHEREAS, the NCHLC has since sustained an active program of cataloging and recommending for designation historical sites and structures throughout Nevada County; and

WHEREAS, the NCHLC accepts applications, processes and verifies applications for proposed historical landmark designation, and recommends said landmark designations for approval by the Nevada County Board of Supervisors; and

WHEREAS, the Board of Supervisors supports the promotion of the public health, safety, and general welfare by providing for the identification, protection, enhancement, perpetuation, and use of improvements, buildings, structures, signs, objects, features, sites, places, districts, and areas within the County that reflect special elements of the County's architectural, artistic, cultural, engineering, aesthetic, historical, political, social, and other heritage, by allowing their registration as Nevada County Historical Landmarks for the following reasons:

1. Safeguarding Nevada County's heritage as embodied and reflected in the Eagle Hose Company Site and its influence on Nevada County's cultural and social history, and commemorating the valuable role it played in this community; and
2. Encouraging public knowledge, understanding, and appreciation of Nevada County's history as reflected in its heritage; and
3. Fostering civic and neighborhood pride and a sense of identity based upon the recognition and use of cultural resources; and
4. Preserving diverse and harmonious architectural styles and design innovations; and
5. Enhancing property values to increase economic and financial benefits to Nevada County and its inhabitants by preserving and promoting historical buildings; and
6. Protecting and enhancing Nevada County's attraction to tourists and visitors, thereby stimulating business and industry; and

7. Identifying as early as possible, and resolving conflicts between the preservation of cultural resources and alternative land uses in a section of Nevada County that may see future population growth; and

WHEREAS, NCHLC received an application from the City Planner of the City of Grass Valley, Amy Wolfson, on March 11, 2025, requesting that the Eagle Hose Company Site, located at 139 East Main Street, Grass Valley, CA 95945 (APN 008-348-002), be designated as a Nevada County Historical Landmark; and

WHEREAS, at its April 25, 2025, meeting, the NCHLC verified and unanimously approved the application and now recommends that the Board of Supervisors designate the property as a Nevada County Historical Landmark.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Nevada hereby accepts the NCHLC's recommendation and designates the Eagle Hose Company Site, located at 139 East Main Street, Grass Valley, CA 95945 (APN 008-348-002), as Nevada County Historical Landmark NEV 25-09.

BE IT FURTHER RESOLVED that the Clerk of the Board is hereby directed to record a certified copy of this Resolution with the Office of the Nevada County Clerk-Recorder within ten (10) days after the adoption hereof.

Honorable Chair and Board Members:

At our last meeting, the Nevada County Historical Landmarks Commission voted unanimously to recommend to the Board that the application for landmark designation of the Eagle Hose Company, located at 125 East Main St. in Grass Valley, be approved. The applicant is the City of Grass Valley. The landmark is to be designated as Nevada County Historical Landmark NEV 25-08, assuming the pending applications are approved first.

The Eagle Hose Company was organized in 1866 as the City of Grass Valley's second volunteer fire company. It moved into a building reportedly erected in 1858. In 1937, that building collapsed during a severe snow storm. The present building was then built on the site and continued to serve as a fire station for many years. It also served as a community meeting place for groups like the Campfire Girls. Its importance to the City of Grass Valley was due in part to its housing the signal bell for the numerous fire alarm boxes located throughout the City, which alerted the firefighters and the citizenry of a fire's location. In April 1945, the bell sounded a special signal to announce to Grass Valley citizens the official defeat (V-E day) of Nazi Germany. That system continued in use until it was replaced by a system of electronic communications.



The research and documentation which accompanies the application has been reviewed by several Commissioners for historical accuracy. The application and supporting documentation is enclosed.

If you approve the application, please forward the resolution and accompanying documents to the County Recorder.

Brief history and description of proposed landmark

The Grass Valley Fire Department was first organized in 1853. It is the third oldest active fire department west of the Mississippi according to the City of Grass Valley Fire Department History. On June 7, 1858, the fire company was recognized under law as the Grass Valley Hook and Ladder Company. Over the course of 42 years, three additional ladder companies were added. Protection Hose Company No. 1 established in 1858 was located at Main and School Streets and later moved to Brighton Street where it remains today.

Eagle Hose Company No. 2 was added in 1866 and located on East Main Street near City Hall. In February 1937 a severe snowstorm flattened the structure, only the front wall and the city signal fire bell remained. The signal bell was moved to city hall where the Fire Safe Council of Nevada County maintains offices. See attachment # 9, a photo of Eagle Hose Company No. 2

Historically significant aspects or properties of proposed landmark

Landmark recognition is being requested for the site of the Eagle Hose Company No.2, home to the volunteer Fire Brigade founded in 1866.

The current building on the site of the Eagle Company No. 2 is owned and maintained by the City of Grass Valley.

Historical Significance of proposed landmark and why it is important to recognize:

The Eagle Hose company managed multiple fire alarm boxes to alert neighborhoods of fires. In 1919 they purchased the 21st alarm box and placed it in the Washington street hill vicinity to increase the coverage for outlying neighborhoods.

Volunteer fire fighters were alerted and directed to the area of a blaze by the Alarm System, which used a numbering system located on the fire alarm boxes. Volunteer fire brigades were the backbone of fire and rescue services in towns and rural areas.

See attachment #10 for a list of numbers used to identify neighborhoods in 1928 curtesy of the Union Newspaper. This was method was hugely important for swift communication and was used for over 100 years. The Alarm notification system became obsolete with the advent of electronic communication.

Attachment 1

FIRE DEPARTMENT HISTORY



The Grass Valley Fire Department was first organized in 1853 with the establishment of a Hook and Ladder Company. It is the third oldest active fire department west of the Mississippi River. June 7, 1858 marked the day that the fire company was organized under law as the Grass Valley Hook and Ladder Company. In 1861 the Grass Valley Hook and Ladder Company was reorganized into Protection Hose Company No. 1 and then again into Protection Engine Company No. 1. The original station No. 1 was located at Main and School Streets, it later moved to the current location of City Hall and then to Brighton Street where it has remained since.

Over the course of 42 years three additional ladder companies were added to the department. On July 18, 1866, Eagle Hose Company No. 2 was organized and was located on East Main Street near City Hall, where the Fire Safe Council of Nevada County maintains there offices. On March 31, 1891 the Reliance Hose Company No. 3 was established with a station on Race Street, which still serves the Fire Department, it is no longer an active station but remains part of our rich history. In 1895 the Defiance Hose Company No. 4 was organized to protect the Boston

Ravine area, located at Mill Street and Empire Street. The Defiance Hose Company operated for nearly 25 years, but disbanded in 1920.

In 1915, the fire department purchased its first motorized piece of fire apparatus, The Pierce Arrow, and by 1916 two additional motorized fire apparatus were added to the fleet.

The Grass Valley Fire Department currently operates out of three stations. Station No. 1 located on Brighton Street and Station No. 2 located on Sierra College Drive and Station No. 5 located at 201 Providence Mine, Nevada City. Today the Department has 29 career personnel and provides protection to the 5 square miles of the City of Grass Valley as well as the City of Nevada City and outlying portions of Western Nevada County.

GRASS VALLEY FIRE DEPARTMENT



GRASS VALLEY today has one of the best organized volunteer fire departments in the State. Its efficiency has been proven upon many occasions and with our excellent water system Grass Valley is as well protected from the ravages of the Fire King as any city on the Coast.

The first fire organization was a hook and ladder company formed in 1853, before the town had suffered from a conflagration. This company existed for about a year and made a parade in uniform in October, 1854. The first Board of Trustees passed an ordinance on July 3, 1855, which required the occupant of every house to keep on hand a vessel containing at least fifty gallons of water and four fire buckets for each story of his house.

The first regular fire company organized under the law was formed June 7, 1858, and known as the Grass Valley Fire Hook and Ladder Company. Its first officers were: S. M. Smith, foreman; J. J. Dorsey, first assistant foreman; C. R. Edwards, second assistant; E. C. Cheek, secretary, and G. A. Montgomery, treasurer. The company used a building on the corner of Main and School Streets, tendered them by A. B. Dibble. This company did good work and was reorganized June 17, 1861 into Protection Hose Co. No. 1. It was proposed shortly before this to organize a hook and ladder company, the new organization to take the apparatus of the former company. This was done and a fire department was formed, and Union Hook and Ladder Company was formed with N. C. Hammersmith as foreman, John Blake, assistant foreman; Chas. Glasen, president; Sol. Crown, treasurer. Hammersmith soon afterwards decamped with \$200 of the companies funds and the organization disbanded. The officers of Protection Hose Company were:—S. D. Leavitt, foreman; G. Hamilton, first assistant; T. J. Cook, second assistant; J. M. Days, secretary; H. Silvester, treasurer.

In March, 1863, Eureka Hose Company, No. 2 was organized with Schenck Glass, foreman; C. R. Clarke, first assistant; John Blake, second assistant. This company disbanded the same year. On August 25, 1863,

Tiger Hook, Ladder and Bucket Company, No. 1, was organized as an independent company, but soon after joined the department. The old engine house of the department was destroyed by fire on June 11, 1862, and two lots were purchased from W. S. Byrne and Sam Hodge on Main Street, the present engine house, used also as a city hall, being erected the following year. The first meeting held in the new house was on March 2, 1863.

Eagle Hose Company, No. 2, was organized July 18, 1866, and its first officers were:—John R. Crocker, foreman; E. R. West, first assistant; John W. Hobby, second assistant; C. E. Davis, president; George Murphy, secretary; Peter Brunstetter, treasurer.

The present department is composed of three companies, Protection, No. 1, Eagle, No. 2, and Reliance, No. 3. The cuts of Protection and Eagle companies appear in this edition.

The following are the officers of Protection, No. 1: President, W. H. Morgan; secretary, Henry Daniels; treasurer, Wm. Curtis; foreman, John F. Buckett; first assistant, B. A. Van Slyke; second assistant, A. J. Bovey. Members:—J. P. Miller, Oscar Klein, F. A. Campbell, John Frank, C. J. Miller, Wm. Freeman, James Lucas, W. H. Morgan, H. Daniels, John F. Buckett, John Aver, W. D. Paynter, Wm. Curtis, Chas. Dahlgren, S. J. Kinsman, B. A. Van Slyke, Frank E. Dennen, Wm. Provis, B. F. Schwartz, Theo. A. Kohler, D. S. Collins, A. J. Bovey, C. Temby, Jr., Wm. Henrici, Wm. Simmons.

The officers of Eagle Hose Company are as follows: President, S. R. Wilder; secretary, Geo. A. Wanamake; treasurer, W. G. Lord; foreman, Samuel Blight; first assistant, James Stead; second assistant, Alex. Chesneau. Members:—S. R. Wilder, Geo. A. Wanamake, W. G. Lord, L. C. Snyder, John Lucas, Geo. Wettereau, W. G. Frank, James Hosking, James Stead, G. W. Hobby, John Hocking, Adolph Ruck, Joseph Hall, Thomas F. Collins, C. E. Uren, M. Shewbridge, Alex. Chesneau, John H. Snow Flattens Headquarters of Eagles Firemen

One of Grass Valley's landmark structures—the Eagle firehouse — which has experienced more snow storms than most buildings of the city and certainly has gone through several storms of equal severity to the present, crashed at 4:15 o'clock Sunday afternoon, almost as flat as the proverbial pancake.

Literally pushed over by the heavy snow accumulation, the firehouse became a tangled mass of splintered boards and debris, although the frontwall and the city signal firebell remained in the air, if slightly askew.

The firehouse contained the Buick hose truck of the local department and was equipped and furnished as the clubrooms for the fire company.

The building is practically a total loss, although rebuilding is possible of the fore room where the fire fighting equipment stood.

It was reported yesterday that the building was first erected in 1858 and had served as a firehouse for the community through a long period of years. In the old handcart days, it stood as one of the city's foremost firehouses.

The signal bell will be removed to the city hall building and the fire company will discuss disposition of the structure at their regular meeting this evening, which will be held at the Protection headquarters.

With identical bids submitted as those of a week ago, when the first call was made for the figures on construction of the new Eagle firehouse and social hall on East Main street, Paul I. Jenks, was awarded the contract by the city council of Grass Valley at last night's meeting and will proceed with the job at once.

Jenks bid of \$3580.20 was accompanied by a certified check for 10 percent of the construction figure last night. Omission of this item resulted in the bids being rejected at the adjourned council meeting of a week ago.

Ralph Cochrane placed his same bid of \$3639, which was \$59 higher, in accordance with his assertion to place the same figure, when the two bids publicly opened and read a week ago were given publicity.

The city of Grass Valley is placing the foundation walls for the new firehouse and will fill the lot to street grade.

The Jenks bid listed 10 alternates which were changes from the original specifications if the council so desired.

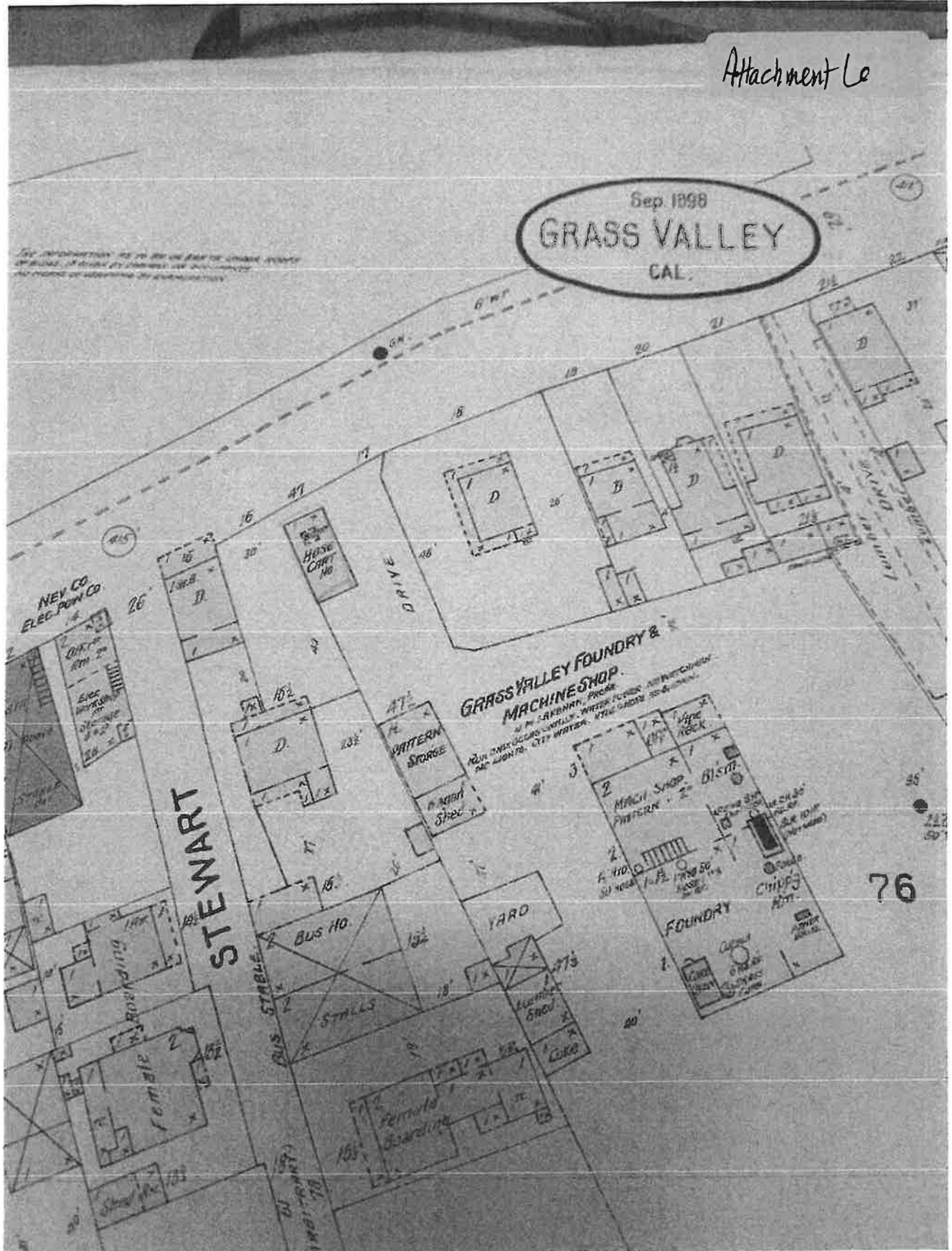
EAGLE HOSE COMPANY 1910



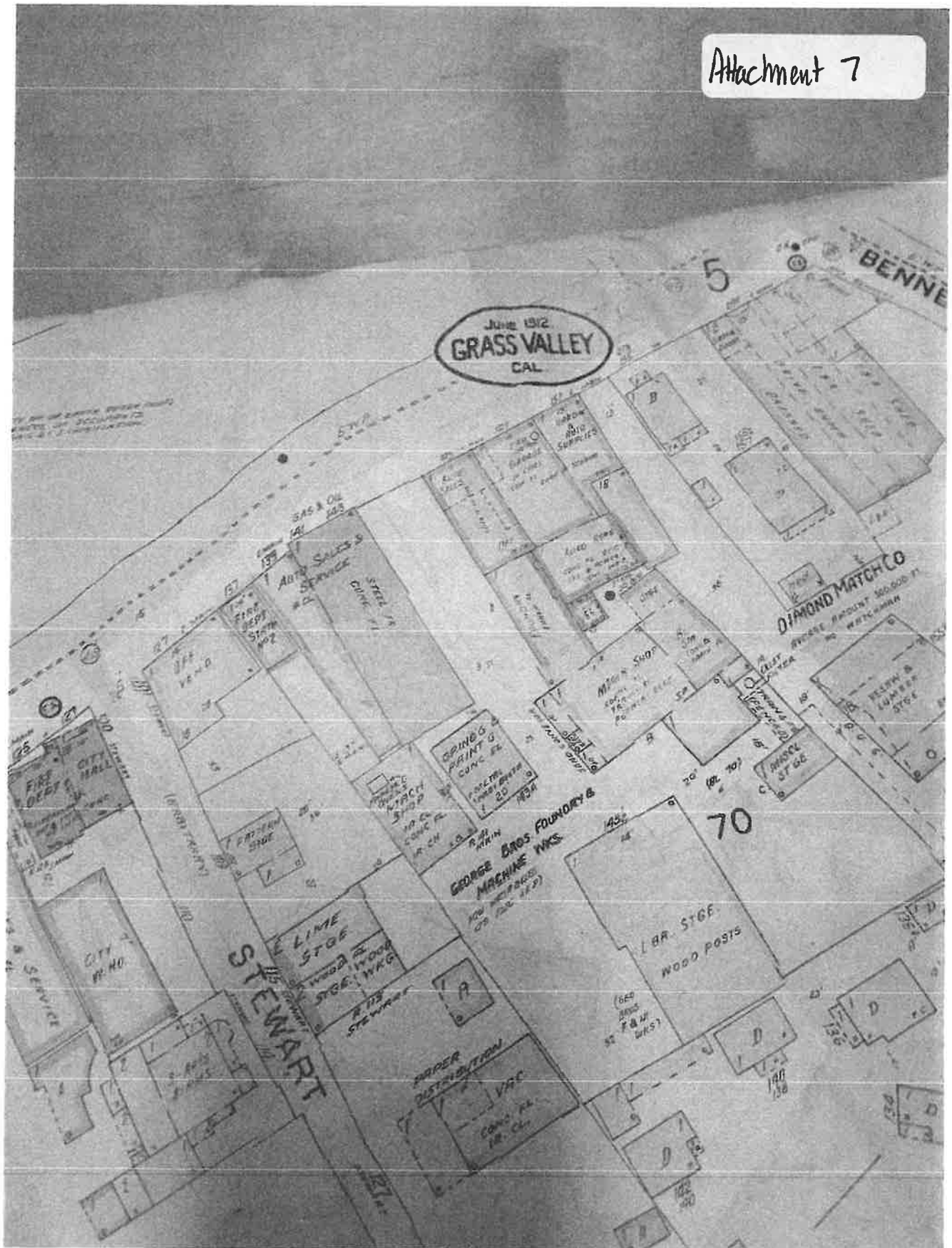

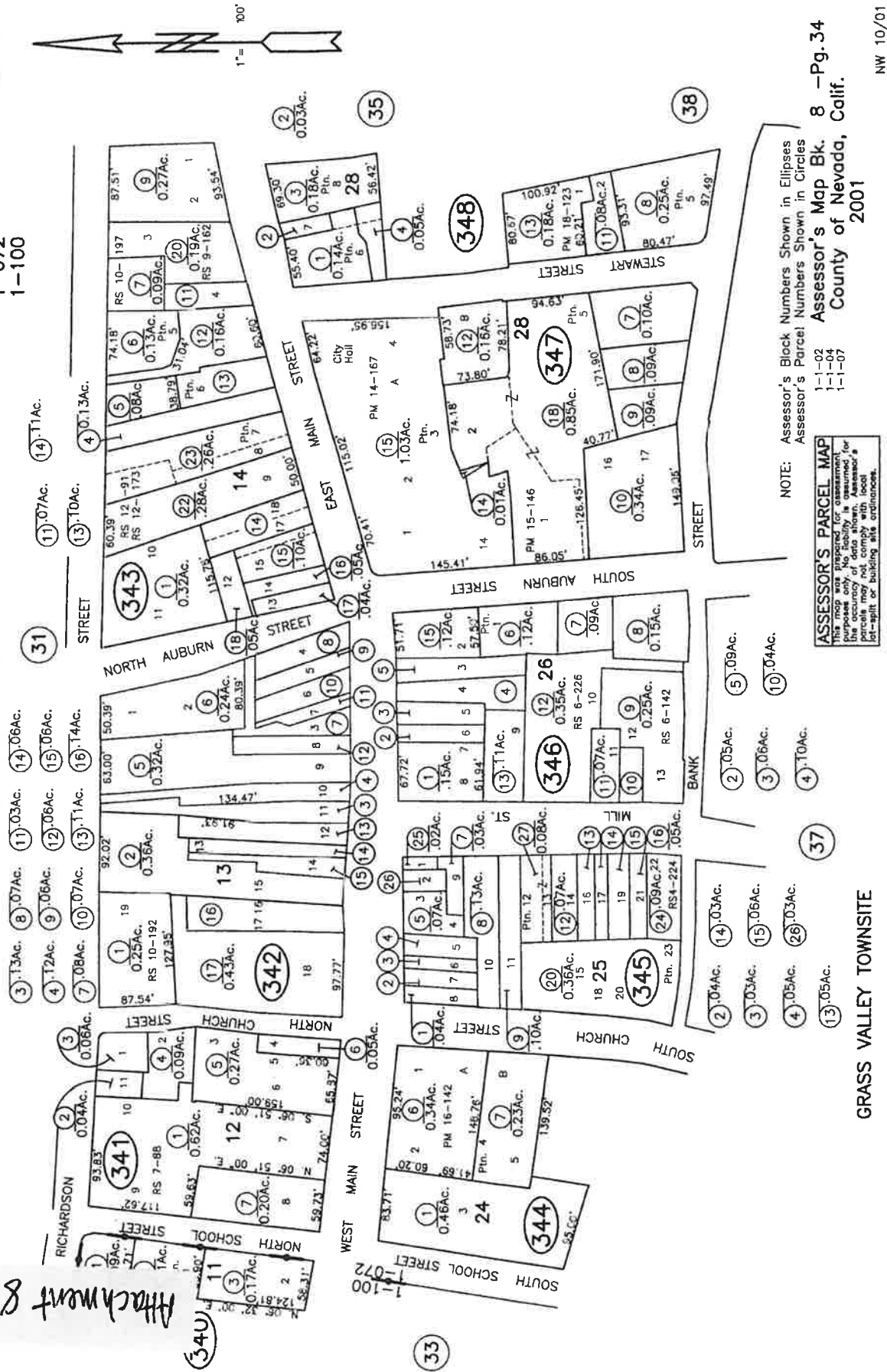
