

ACTION TAKEN (Continued): In response to questions raised by the public regarding Agenda Item No. 30, Chair Hoek requested staff clarify the process followed for managing the contract.

Ariel Lovett, Project Administrator, and Caleb Dardick, Assistant County Executive Officer, explained that the process for awarding resiliency grants began in April 2021, when the Board of Supervisors allocated \$5.8 million of Nevada County's American Rescue Plan (ARPA) allocation to the community and economic development priorities to provide relief and recovery to businesses, non-profits, and special districts. The funding was awarded following review of the proposals by a panel comprised of County staff and members of the community. The panel recommended to the Board that a total of thirty-two entities receive the resiliency grant funding. Most of these grant agreements have already been approved by the Board; this contract is now ready for Board approval. Alison Lehman, County Executive Officer, reported that information regarding the ARPA funding is available on the County's website for public review.

MOTION: On a roll call vote, the motion passed unanimously.

ACTION TAKEN: Chair Hoek introduced the item, and Gregory Diaz, Nevada County Clerk-Recorder/Registrar of Voters, reported on the process of certifying the Statement of Votes cast on June 7, 2022. Registrar Diaz requested the Board declare the candidates with the highest amount of votes be elected to office. Registrar Diaz explained that the 1% audit (a total of 446 votes) has been completed. No variances were found between the manual count and machine count. One ballot was found to be missing, and in the interest to be transparent he noted the missing ballot in the certification paperwork. The Registrar certified the Statement of Votes on the June 29, 2022.

Chair Hoek provided an opportunity for public comment and comments were received.

Registrar Diaz responded to the question received during public comment regarding the 1% recount, which is a total of 379 ballots. The Elections Office counted a total of 446 ballots. Registrar Diaz explained that following each election, the Elections Office must pull 1% of all ballots cast, to complete a manual recount of the ballots.

The 1% recount must include each contest on all ballot types that are issued throughout the County. Furthermore, Elections staff verifies the signature on each and every ballot with their records to prevent individuals from voting more than once.

In response to questions regarding maintenance of the Voter Role, Registrar Diaz explained that this is addressed year-round. If a member of the public has specific questions regarding the Voter Role, they are invited to make an appointment with him to discuss their concerns.

Board questioning and discussion ensued.

ACTION TAKEN: Phebe Bell, Director of Public Health, and Eli Gallup, Associate Superintendent, Special Education/SELPA, provided a PowerPoint presentation regarding behavioral and mental health services provided in Nevada County elementary schools as funded by the Mental Health Student Services Act.

Approximately \$2.5 million dollars were received through the Mental Health Student Services Act, resulting in the program. Eight Registered Behavioral Technicians and two Board Certified Behavioral Analysts have been hired through Nevada County Superintendent of Schools and are currently located at the County's elementary schools. This increases in-class behavioral support and capacity, and strengthens connections and referral flow between school support staff and Nevada County Behavioral Health. In the first six months of the program, twenty-nine students have been served. An additional \$674,602 has been awarded, and staff will return to the Board to accept the funds. Director Bell requested the Board adopt the Resolution approving the contract.

Staff responded to Board questioning and discussion ensued.

Chair Hoek opened the opportunity for public comment, and comments were received. There being no further public comment, Chair Hoek closed the opportunity for public comment.

ACTION TAKEN: Jeff Goldman, Nevada County Chief Probation Officer, provided an overview of the work of Probation Officers, and spoke highly of the County's Probation staff. The Department currently supervises over 400 juvenile and adults.

Deputy Ben Hertzell, Deputy Probation Officer, provided comments regarding the work he does with juveniles and young adults within the community who are under Probation's oversight. Deputy Hertzell reviewed the day-to-day work of Probation officers and the programs that are offered to those in the Probation system.

Nicole Carman, a previous client of the Probation Department, spoke of being a client of Nevada County's Probation Department. Nicole shared her story of success, and spoke to the amount of support clients receive throughout the Probation process. Nicole now has full custody of her children, has finished her education, is employed, and has had the pleasure to watch her oldest daughter graduate from high school.

Board questioning and discussion ensued.

Chair Hoek provided an opportunity for public comment and no comments were received.
