OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION REAFFIRMING AND APPROVING THE SUBMITTAL OF AN APPLICATION FOR FUNDING AND THE EXECUTION OF A GRANT AGREEMENT AND ANY AMENDMENTS THERETO PERTAINING TO THE 2019/2020 FUNDING YEAR OF THE STATE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

WHEREAS, the California Department of Housing and Community Development (“HCD”) announced the availability of approximately \$60 million in funding for the Community Development Block Grant (“CDBG”) Program representing funding for the 2019-2020 program years; and

WHEREAS, the CDBG application was due on April 15, 2020, and the Board of Supervisors approved the submittal of the application on March 24, 2020 per Resolution 20-087; and

WHEREAS, this CDBG funding is for various programs including Public Services, and Housing Programs; and

WHEREAS, HCD has requested that the original Resolution be amended to meet specific funding requirements; and

WHEREAS, the Board of Supervisors reaffirms its authorization and approval of Health and Human Services Agency’s preparation and submission of the application in the amount of up to \$1,979,500; and

WHEREAS, upon receipt of a grant agreement, the Director of Health and Human Services, or designee is authorized to sign the standard agreement with the State of California for the purposes of this grant.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Nevada, State of California, authorize the submittal of one or more application(s) in the aggregate amount of \$1,979,500 for the following CDBG activities, pursuant to the January 2020 CDBG NOFA, and;

BE IT FURTHER RESOLVED that the Board authorize as follows:

SECTION 1:

List activities and amounts

Public Service Program: Senior Services	\$ <u>350,000</u>
Public Service Program: Nutritional Services	\$ <u>500,000</u>
Housing Program: Owner Occupied Rehabilitation	\$ <u>750,000</u>
Planning Grant: Resource Center Development	\$ <u>250,000</u>
General Administration	\$ <u>129,500</u>

Total CDBG Funding Application: \$ 1,979,500

SECTION 2:

The County acknowledges compliance with state and federal public participation requirements in the development of this application.

SECTION 3:

The County hereby authorizes and directs the Director of Health and Human Services, to sign this application and act on the County's behalf in all matters pertaining to this application.

SECTION 4:

If the application is approved, the Director of Health and Human Services, or designee, is authorized to enter into and sign the grant agreement and any subsequent amendments thereto with the State of California for the purposes of this grant.

SECTION 5:

If the application is approved, the Director of Health and Human Services or designee, is authorized to sign Funds Requests and other required reporting forms.

SECTION 6:

The Director of Health and Human Services or designee, will return to the Board of Supervisors to provide an informational update should the application be approved.
