**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

**RESOLUTION AUTHORIZING THE PURCHASE OF A CAPITAL ASSET RAMPSTAR R010 REFUELING TRUCK AND TO AMEND THE FISCAL YEAR 2014/15 AIRPORT BUDGET**

WHEREAS, the Nevada County Airport has the responsibility to provide Jet A fuel to emergency aircraft operating out of the Nevada County Airport and the current Jet A refueling truck is 28 years old and experiences routine mechanical reliability issues; and

WHEREAS, the increased capabilities of the R010 can cut the refueling time of a fire-fighting tanker aircraft and the standard United States Forest Service (USFS) Air-Tactical aircraft by 50% to enable faster reload and return times to local wildfires; and

WHEREAS, the ability to refuel aircraft faster enables more aircraft to be sent to Nevada County Airport for reloading and returning to any regional fire-fight due the additional refueling capacity; and

WHEREAS, the cost analysis and return-on-investment study show the R010 will be paid for in 2.75 years versus leasing for six years, with a minimum useful life remaining of at least ten years, but likely 20 plus years; and

WHEREAS, the Nevada County Airport Commission endorsed the purchase of the RAMPSTAR R010 Fuel truck at the regular Airport Commission meeting on January 8, 2015.

NOW, THEREFORE, BE IT HEREBY RESOLVED, that the Board of Supervisors, of the County of Nevada, State of California:

1. Authorizes the purchase of a capital asset, a RAMPSTAR R010 Refueling truck in the amount of \$57,042; and,
2. Directs the Auditor-Controller to amend the Fiscal Year 2014/15 Airport budget as follows, and to utilize \$21,042 of Airport fund balance to purchase the capital asset:
