RESOLUTION AUTHORIZING THE NEVADA COUNTY SHERIFF TO ACCEPT A GRANT FROM THE RUDIGER FOUNDATION IN THE AMOUNT OF \$31,300.00 FOR A ONE YEAR PERIOD COMMENCING NOVEMBER 1, 2021, TO FUND A K9 PROGRAM FOR THE SHERIFF'S OFFICE

WHEREAS, the Rüdiger Foundation desires to grant an amount of \$31,300.00 to fund a second K9 program in the Nevada County Sheriff's Office and the Board of Supervisors of the County of Nevada desires to accept the grant for the K9 Program; and

WHEREAS, the grant will provide funding towards the purchase and training of a dog, upfitting of a vehicle for K9 purposes, additional necessary equipment and care and feeding of the dog for a one-year period commencing November 1, 2021.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of Nevada County accepts the grant from the Rüdiger Foundation, for reimbursement of expenses for a second Sheriff's Office K9 Program not to exceed \$31,300.00 and that the Sheriff of Nevada County is hereby authorized to execute the Agreement on behalf of the County of Nevada.

Congratulations! We are pleased to inform you that the Rüdiger Foundation (RüF) has approved your grant of \$31,300 for the acquisition of a 2nd K9 Officer for the Nevada County Sheriff's Department (NCSO). These grant funds are to be used specifically for the acquisition and outfitting of a K9 Officer and will be dispersed upon qualifying receipts provided by the NCSO. This grant approval covers the attached funding request and will be in place for the term of one year from the date of this letter. RüF will consider, contingent upon funding, requests for ongoing training costs and other one-time expenditures on a case-by-case basis beyond the terms of this grant period and maximum grant award. Any application for ongoing training and one-time expense grants will be reviewed annually as part of the Rüdiger Foundation annual budget. The offer of this grant is subject to the NCSO's agreement to:

- 1. Provide itemized receipts for costs to be reimbursed from grant funds. Maximum costs to be reimbursed are attached herein.
- 2. Upon reimbursement of expenses, written acknowledgment of receipt funds will be provided to RiiF.
- 3. Cooperate with efforts of the Rüdiger Foundation to publicize the partnership with the agency to sustain local K9 Officer programs. Examples of this include mentions of RüF in K9 related social media posts or other publicity opportunities.

If the Nevada County Sheriff's Office agrees to these terms, please have an authorized representative sign and return one copy of this letter. We appreciate being able to assist you with your efforts.
