

ACTION TAKEN: Mr. Gregory Diaz, Clerk-Recorder/Registrar of Voters, provided comments regarding the safety of mail-in voting, and reported that the early voting process began on October 5, 2020. His office has received over 7,000 ballots to date. He expressed his hope that as Election Day approaches, they will have the time to process the ballots so they will be part of the Election Day count. Mr. Diaz explained that the election cannot be certified until November 20, 2020 to provide 17 days to contact any voters who have errors on their ballots.

Ms. Natalie Adona, Assistant Clerk-Recorder, provided a PowerPoint presentation regarding the upcoming November 2020 Election. She provided an overview of issues relating to administering Elections during COVID-19. While ballots are mailed to all County registered voters, ballots can be returned by mail, dropped off at a vote center, or at the Eric Rood Administrative Center. Ms. Adona verified that in Nevada County, voting will be secure and safe; they have added updated vote centers and drop boxes; they will be requiring Personal Protection Equipment (PPE) for vote center workers; vote center workers are provided training; voters can check to verify online that their mail-in ballots have been received; and waiting areas at all poll sites will have social distancing. Ms. Adona reviewed the Election security features that are in place, and she reported on the challenges they are expecting in 2020, including: misinformation; COVID-19; Public Safety Power Shut-off events, de-escalating tense situations; voter intimidation and suppression; and post-election reactions.

Board questioning and discussion ensued. No public comment was received for this item.

This will address individuals in need of treatment rather than having them end up in the criminal justice system, additionally it will provide an opportunity to connect them with community resources and support.

Ms. Lela Walls, District I resident and NAMI (National Alliance on Mental Illness) Nevada County representative, provided comments. There being no further members of the public waiting to provide comments, Chair Hall closed the opportunity for public comment.

The Board of Supervisors shall consider all objections and protests, if any, to the proposed parcel charges and will tabulate the vote on the proposed parcel charges. A majority protest will exist if, upon the conclusion of the hearing, assessment ballots submitted in opposition to the proposed assessment amendment exceed assessment ballots submitted in favor of such proposed parcel charge. Only one ballot shall be counted for each parcel, even if there are co-owners, with ballots weighted according to the proportional financial obligation of the affected property. In addition to the ballots in favor of or in opposition to the proposed assessment, the Board of Supervisors will also consider any other protests to the proposed assessment at the public hearing. If a majority protest exists, the Board of Supervisors will not impose the amended parcel charges. He reported that the industry decreased in 2019 mostly from decreased timber production, as well as income from livestock. There were increases in fruits and vegetables, wine production, nursery products, eggs, apiaries and honey production. Mr. de Nijs highlighted sustainable agricultural activities, including: inspections for live exotic pests, placing 428 insect traps; pesticide permits for both organic and conventional chemicals, and the issuance of certificates for Certified Producers, Farmers and Registered Organic producers. He explained that cannabis is currently not included in the crop report, and he asked the Board for direction on whether they would like to see a cannabis report in future years.

Board questioning and discussion ensued.

Chair Hall recognized that to add cannabis would be a large effort, but felt it would be very important to include in the annual report. Mr. de Nijs added that it would be a supplemental report. Supervisor Miller would like to wait until the cannabis industry was further along before it was included in the report.

Chair Hall provided an opportunity for public comment, and the following members of the public provided comments: Ms. Diana Gamzon, Executive Director, Nevada County Cannabis Coalition. There being no further members of the public wanting to speak, Chair Hall closed public comment.

Consensus was provided to include the Cannabis report in the Annual Agricultural Report, starting in 2021 (Board Order).

Board Order BO-20-02 opened to add the cannabis industry to the 2020 Annual Crop and Livestock Report.

MOTION: Motion made by Supervisor Hoek, seconded by Supervisor Scofield, to accept the 2019 Annual Crop and Livestock Report. On a voice vote the motion passed unanimously.

ACTION TAKEN: Ms. Amy Irani, Environmental Health Director, reviewed the staff report regarding Environmental Health Department's waiver of permit fees in Fiscal Year 2020/21 for restaurants, bars, body art and tattoo, public pool and spa and organized campground facilities, as a response hardships caused to these businesses due to the COVID-19 pandemic. Ability to apply for this waiver through an online application will begin in October 23, 2020, and sunset on November 30, 2020. Businesses requesting a waiver must continue to be in good standing with the State's public health COVID-19 requirements.

Board discussion ensued and Ms. Irani responded to the Board's questions. Mr. Barry Anderson, Management Analyst, responded to Board questions relating to the County budget.

No public comment was received on this item.
