## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 3 TO THE CONTRACT BETWEEN THE COUNTY OF NEVADA AND GENUINE PARTS COMPANY FOR THE VENDOR MANAGED INVENTORY PARTS FACILITY OPERATIONS TO INCREASE THE CONTRACT AMOUNT BY \$210,000 FOR A NOT TO EXCEED TOTAL OF \$990,000

WHEREAS, the Nevada County Board of Supervisors (Board) approved and adopted Resolution 21-273 awarding a contract for a Vendor Managed Inventory Parts Facility Operations, with the ability to execute three (3) additional annual renewals beginning July 1, 2022; and

WHEREAS, the Board approved Resolution 22-226 approving Amendment No. 1 to increase the contract by \$100,000 for a not to exceed total annual amount of \$740,000; and

WHEREAS, by approving Resolution 22-226 Amendment No. 1 to the contract, the Board also approved to transfer the Assignment Agreement to Genuine Parts Company; and

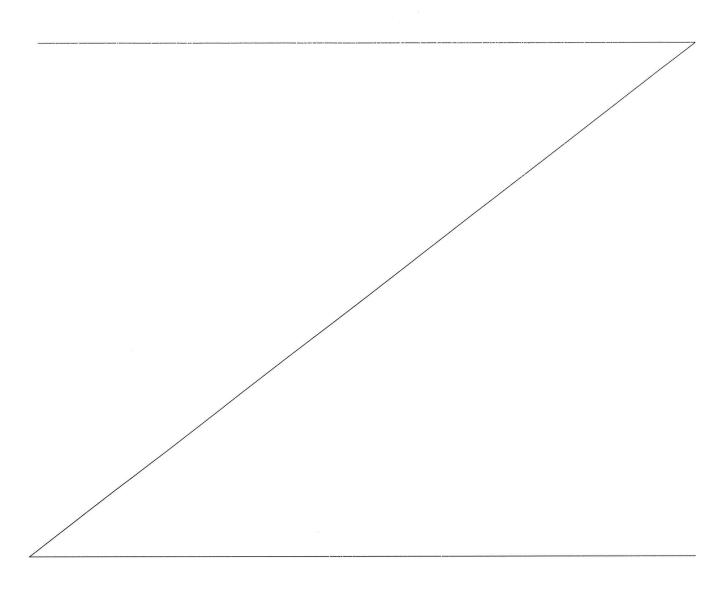
WHEREAS, the Board approved Resolution 22-265 approving Amendment No. 2 with Genuine Parts Company for the first annual renewal of a one-year term from July 1, 2022, through June 30, 2023, with a not to exceed annual contract amount of \$780,000; and

WHEREAS, the Department recommends approving Amendment No. 3 with Genuine Parts Company to increase the contract by \$210,000 for a not to exceed total annual amount of \$990,000.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Approves Amendment No. 3 to the contract and authorizes the Chair of the Board of Supervisors to execute the Amendment between the County of Nevada and Genuine Parts Company for the Vendor Managed Inventory Parts Facility Operations.
- 2. Authorizes the Auditor Controller to encumber the amended total contract amount:

## AMENDMENT No. 3 TO CONTRACT BFS21273 WITH GENUINE PARTS COMPANY

**THIS AMENDMENT** is executed this 13<sup>TH</sup> day of June, 2023, by and between the County of Nevada and Genuine Parts Company. Said Amendment will amend the prior agreement between the parties entitled Vendor Managed Inventory Parts Facility Operations executed on June 22, 2021, by Resolution No. 21-273, and which Agreement was subsequently amended on May 24, 2022 by Resolution No. 22-226, and on June 14, 2022 by Resolution No. 22-265.

**WHEREAS**, unanticipated costly repairs to snow removal equipment and the severity of the recent winter storms necessitates an increase of the contract amount by \$210,000.00 for an annual not to exceed total amount of \$990,000 for FY 2022/23.

## NOW, THEREFORE, the parties hereto agree as follows:

- 1. This amendment shall be effective as of April 1, 2023.
- 2. The contract amount will be increased by \$210,000, for a total annual not to exceed amount of \$990,000.
- 3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
