RESOLUTION NOTICE OF ACCEPTANCE AND COMPLETION FOR THE 2021 NEVADA COUNTY ANNUAL STRIPING PROJECT – COUNTY PROJECT NO. 426639

WHEREAS, the County of Nevada entered into a contract for Project No. 426639 with Central Striping Services, Inc. on August 10, 2021, by Resolution 21-358 for a contract totaling \$149,891.05 plus a 10% contingency of \$14,989.11 for the contract work items, for a maximum not to exceed amount of \$164,880.16; and

WHEREAS, said Contract was for the striping of approximately 112 miles of County roads and was constructed in accordance with the plans and specifications; and

WHEREAS, the Improvements were completed to the satisfaction of the Nevada County Department of Public Works on February 17, 2022, with contract costs totaling \$147,545.22

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Accepts the work as being completed.
2. Directs the Clerk of the Board of Supervisors to release the Bond for Labor on May 16, 2022, and the Bond of Faithful Performance on April 12, 2023.
3. Directs the Clerk of the Nevada County Board of Supervisors to record this notice in accordance with Civil Code Section 9208.
