Dear friends of the proposed Pines to Mines Trail,

As some of you know, the Nevada County Board of Supervisors generously set aside \$100,000 for the environmental and cultural resource studies that must take place prior to construction of the Pines to Mines Trail, as required by the National Environmental Policy Act (NEPA). Funding for NEPA is very hard to come by, so this is a huge opportunity for the Truckee Trails Foundation! An RFP was issued by Nevada County in September to manage the NEPA process, and the Truckee Trails Foundation was recently chosen. HOWEVER, the Board of Supervisors still needs to vote to approve the contract award.

The problem is that there is a small but very loud group of equestrians who will try to convince the supervisors to vote against proceeding with the contract because they are concerned about the **possibility** of Class 1 e-bikes being added to the list of allowable users through the NEPA process. They would rather see the entire project fail than risk a possible increase in bikes on trails. So, after working on this project for 4 years, we are seriously at risk of the entire effort dying because of this small minority.

There is an in-person **Board of Supervisors meeting in Nevada City on Tuesday, with this agenda item arising at approximately 1:15 PM.** While I realize it would be difficult for most (if not all) of you to attend in person, ***I'm hoping you will consider writing a quick e-mail to the three Nevada County Supervisors (e-mail addresses below) who represent swing votes and lend your support to proceeding with the contract and the funding of NEPA studies.***

We are asking that e-bikes be left out of your discussion points but that your support focus on some or all of the following:

- This will be a world-class trail – an 80 mile multi-use experience connecting Truckee with Nevada City, creating additional connections to the Pacific Crest Trail, Grouse Ridge, Reno, and eventually, the Sierra Buttes.
- The trail will feature all that is beautiful about Nevada County, and a diverse trail experience from pines and granite to foothill madrones, with stunning views along the way.
- Because the project is piecing together existing trail, only about 20 miles of new construction will be necessary.
- The trail will be an economic driver to our communities.
- This can be the legacy of this current Board of Supervisors!
- A team of nonprofits has been working for 4 years to get to this point, please vote to support this contract to conduct NEPA studies for Pines to Mines and enable the project to proceed.
