OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION AUTHORIZING EXECUTION OF AMENDMENT NO. 4 TO THE MASTER WORKFORCE PARTICIPATION AGREEMENT 3612-WORK-2023-NC WITH THE CALIFORNIA MENTAL HEALTH SERVICES AUTHORITY (CALMHSA) TO UPDATE RATES LISTED UNDER THE REMOTE SUPERVISION PROGRAM FOR THE TERM JULY 1, 2023, THROUGH DECEMBER 31, 2027 (RES. 23-495) (RES. 25-133)

WHEREAS, on July 24, 2023, the Nevada County Purchasing Agent approved execution of a workforce participation agreement with the California Mental Health Services Authority (CalMHSA) for Workforce Education and Training (WET) activities which was subsequently amended on September 1, 2023, again on September 26, 2023, through Resolution 23-495, and again on April 22, 2025, through Resolution 25-133; and

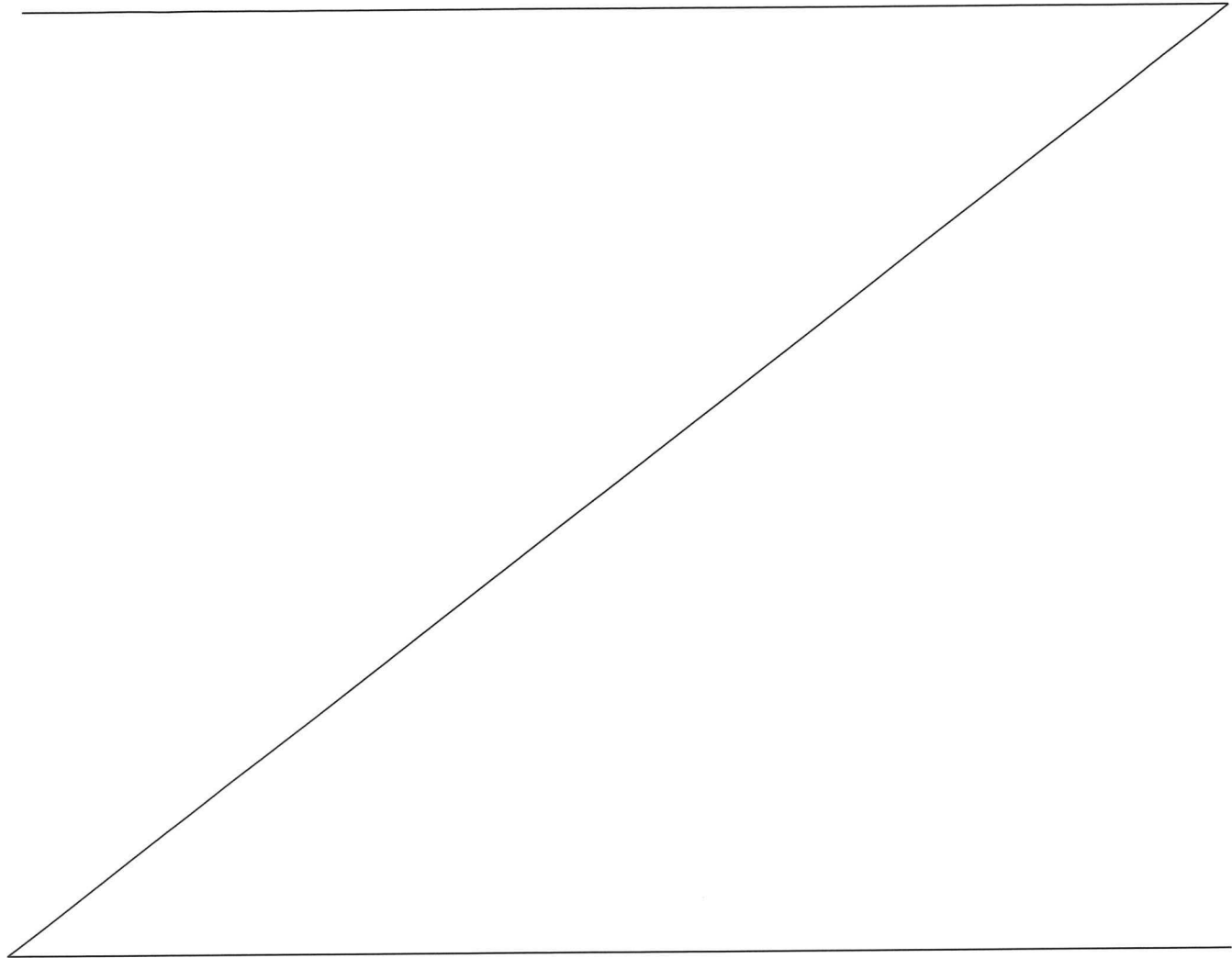
WHEREAS, the overall objective of the agreement was to address the shortage of professionals in the public mental health system; and

WHEREAS, CalMHSA administered the following activities for the County: remote clinical supervision, temporary clinical staffing and permanent staff recruitment, behavioral health mater's level training program, training and certification course, Medi-Cal peer support specialist training and certification, and workforce loan repayment; and

WHEREAS, Nevada County has utilized the agreement to meet clinical demand through utilization of temporary clinical staffing, deploy staff retention strategies, and provide staff development opportunities; and

WHEREAS, Nevada County seeks to amend the agreement again to update rates listed in the remote supervision program for the remaining duration of the Participation Agreement.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 4 to the Participation Agreement by and between CalMHSA, pertaining to the Workforce Education and Training program for the provision of behavioral health workforce development for the term of July 1, 2023, through December 31, 2027, in the maximum amount of \$318,800, be and hereby is approved, and the Chair of the Board of Supervisors, is authorized to execute the Amendment and any necessary documents, on behalf of the County of Nevada.

 MASTER PARTICIPATION AGREEMENT AMENDMENT NO. 4
 Behavioral Health Workforce Program**

This Master Participation Agreement Amendment No. 4 (“Amendment No. 4”) amends Agreement No. 3612-WORK-2023-NC (“Agreement”) and subsequent Amendments (“Amendment”), a contract by and between the California Mental Health Service Authority (“CalMHSA”) and Nevada County (“Participant”) to update the rates listed under the Remote Supervision Program (“Program”). This Amendment No. 4 is effective upon execution.

This Agreement is hereby amended to adjust the Program’s service rates beginning from February 2, 2025 as noted in Exhibit C – Remote Supervision Program, Item II. Budget and Fiscal Provisions, Section A. Rates for Services to reflect the addition of CalMHSA’s 15% administrative fee.
