OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF A SUBGRANTEE AGREEMENT WITH FOOTHILL HOUSE OF HOSPITALITY, DBA HOSPITALITY HOUSE FOR THE CONSTRUCTION OF THIRTEEN BED UNITS OF BEHAVIORAL HEALTH BRIDGE HOUSING AT 246 GLENBROOK ROAD, GRASS VALLEY CA, 95945 IN THE MAXIMUM AMOUNT OF \$975,000 FOR THE TERM OF JULY 25, 2024 THROUGH OCTOBER 1, 2025 AND DIRECTS THE AUDITOR-CONTROLLER TO AMEND THE BEHAVIORAL HEALTH BUDGET FOR FISCAL YEAR 2024/25 (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, Hospitality House is a local non-profit organization that provides emergency shelter and supportive services to Nevada County's homeless population; and

WHEREAS, In November of 2023, utilizing funding awarded by the California State Department of Health Care Services, Nevada County Behavioral Health partnered with Hospitality House to administer and implement the Behavioral Health Bridge Housing (BHBH) Program to provide interim housing and services to individuals who have a severe mental illness, or who have co-occurring severe mental illness and substance use disorders, and who are homeless or at imminent risk of becoming homeless; and

WHEREAS, the Department of Health Care Services has made available BHBH Round 3 funds to eligible counties who had implemented Round 1 funds; and

WHEREAS, the Behavioral Health Department and Hospitality House applied for and were awarded Round 3 funds; and

WHEREAS, a portion of the awarded funds are for the development of thirteen units of BHBH program housing to be constructed on a site owned by Hospitality House.

NOW THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the subgrantee agreement by and between the County and Foothill House of Hospitality, DBA Hospitality House pertaining to the provision of the BHBH Rund 3 award of funding of \$975,000 for the term of July 25, 2024 through Oct 1, 2025, be and hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors is authorized to execute the agreement on behalf of the County of Nevada and directs the Auditor-Controller to amend Behavioral Health's budget as follows:
