**BACKGROUND:**

Currently there is a vacancy on the Agricultural Advisory Commission (AAC) for the Equine Industry position. This position has been advertised and posted on the bulletin boards outside the Board of Supervisors Chambers, Board of Supervisors Office, Madelyn Helling Library, Grass Valley Library, Truckee Library, Truckee Joseph Center, Truckee Town Hall, the District V Board of Supervisors Office in Truckee, and on the My Nevada County website since February 24, 2016. No qualified applications have been received.

Ms. Chris Flores, Agricultural Commissioner, has discussed this position with members of the AAC, and has received approval from Chairman Miller for the proposed redesignations. The Commissioner and the Commission members would like to have Ms. Pam Stone redesignated from the Livestock Other Than Cattle and Equine Industry position to fill the vacant Equine Industry position, and to redesignate Mr. Brad Fowler from the Agricultural Interests position to the Livestock Other Than Cattle and Equine Industry position. This will leave the Agricultural Interests position open. This position is available to a wider range of qualified applicants.
