

NOTICE OF PUBLIC HEARING

Notice is hereby given that on Tuesday, September 10, 2024 at 10:00 a.m. or as soon thereafter as the matter may be heard, the Nevada County Board of Supervisors will hold a public hearing to consider adoption of a resolution to form the Red Dog Road Underground Utilities District. The Board of Supervisors shall consider all objections and protests, if any, to the proposed district formation. Any interested person shall be permitted to present written and/or oral testimony.

The public meeting will be held at the Eric Rood Administration Center Board of Supervisor Chambers, located at 950 Maidu Avenue, Nevada City.

Any person wishing to offer testimony on this matter may submit comments to the Clerk of the Board **in advance** of the meeting by:

In order for comments to be entered into the administrative record of the meeting, they must be received no later than 4:00 p.m. the day before the meeting.

During the September 10, 2024 public hearing, you may provide live public comments by:

- 1) Calling 1 (530) 270-3474 and waiting on standby to be admitted into the meeting remotely;
- 2) Attending the public hearing at the Eric Rood Administrative Center Board Chambers.

Please provide your name, City or District of residence, and reference the **Red Dog Road Underground Utilities District public hearing** as your topic of interest.

A hearing at the Board of Supervisors meeting is required for establishment of the Utility Undergrounding District. All affected parcel owners are required to be notified by Certified Mail in advance of the Underground Utility District formation hearing. Comments will be heard and considered by the Board of Supervisors at the September 10, 2024 public hearing. the Board of Supervisors will decide whether to establish the Undergrounding Utility District.

In addition, an informational meeting will be held August 28, 2024 at 6:00 p.m. in the Eric Rood Administrative Center Board Chambers. All affected property owners are hereby invited to attend this meeting that will provide information on the project and provide the public with an opportunity to ask and have questions answered about the project.
