You will be deciding on a resolution today regarding approval allocating of up to \$20,000 of unexpended fund for signage, parking, and road surfacing improvements on Hirschdale Road.

As a community the Hirschdale community has sent and filed multiple responses to numerous environmental issues in the past regarding Hirschdale road since 2007. We have signed as a community multiple issues regarding environmental issues which affect our community which are all public record. We won on multiple occasions on these environmental issues to the point Teichert was told by the Planning Commissioners that they had to construct an alternative roadway away from the Hirschdale community as the environmental issues brought to the Planning Commissioners were obvious to affect our community. As a result, to the numerous environmental issues brought to the Planning Commissioners and the Board, Teichert then built their alternative roadway for their mine.

Why is the County now wanting to bring issues to our community again with their Resiliency Plan and now spending county funds after our bringing much of the issues we already have fought and won through our community agencies. These responses go back to 2007 and on and they are of public record.

The County has now taken on the position to not include the Hirschdale community with any of their plans moving forward even though multiple owners of the Hirschdale Community have asked County to keep us in the loop. We have no map of the proposal to this resolution. We have no communication from County nor representation from our own Board of Supervisor Hardy Bullock. There has been no outreach to our community asking our concerns. I am hearing we will have a meeting on Aug 22nd which is after this resolution would be approved. We should have opportunity before any resolutions are approved.

In the past our Board of Supervisor for our community have reached out to us and respected our concerns as a community very much to our favor not ignoring or eliminating us from communications regarding our community. We have not even had opportunity as a community to raise our concerns to the Resiliency Plan or this proposed resolution, as we have not even been given or included on any plans moving forward that affect our community. Hirschdale Road is the only roadway into the Hirschdale Community and affects every one of us in Hirschdale. Why are we not given notice of Board meetings or anything that affects our community. In the past our Board of Supervisor member has always respectfully reached out to every member of our community to make sure we are being represented along with communication to us as a community.

We are a small community but any decisions that are decided upon concerning Hirschdale Road affects our Community directly.

I ask that this resolution not be approved until there is communication with the Hirschdale Community as a whole and we have a chance to voice our concerns regarding any issues being presented regarding Hirschdale Road and our community. I also ask that our Board member Hardy Bullock has the consideration to reach out to the community before presenting any further resolutions that concern Hirschdale Road and our community and respects our concerns.

It is specifically stated in the staff report "Improvements, which were discussed with the adjacent community members during a site meeting led by Supervisor Bullock held on June 22, 2023. I do not believe this included the Hirschdale community nor did any of us get notice of this meeting. This decision is being made without community recognition.
