**RECOMMENDATION:** Approve the reappointment of Cindy Wilson as Private Sector Representative to the Adult and Family Services Commission for a two-year term ending April 30, 2026.

**BACKGROUND:**

Currently, there are four vacancies and two positions on the Adult and Family Services Commission. The four vacancies include: one Public Sector vacancy for an unexpired two-year term ending April 30, 2025; one Low-Income Sector vacancy for a two-year term ending April 30, 2026; and two Private Sector vacancies for two-year terms ending April 30, 2025. The two positions include: one Private Sector position and one Public Sector position available for two-year terms beginning May 1, 2024, and ending April 30, 2026. These vacancies and positions were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers bulletin board, the Board of Supervisors office, and the County website. Notice was also posted at the Truckee Town Hall and the District V Board of Supervisors office in Truckee.

Cindy Wilson submitted an application for reappointment to the Commission on April 8, 2024. Cindy Wilson has served on the Adult and Family Services Commission as a Private Sector member since June 14, 2022, and is a member in good standing. On April 10, 2024, the Commission recommended Cindy Wilson for reappointment as a Private Sector Representative.
