This Commission assists the County in the management of solid and hazardous waste, and whose participation, review, and recommendation will be required before the County of Nevada may take any final action on solid and hazardous waste matters. The Commission will assist in the development of a comprehensive long-range plan for the disposal and recycling of solid and hazardous waste within the County, and the management of the County's solid waste operations, including all of the financial matters pertaining thereto.

The Commission shall consist of 9 members; two members of the Board of Supervisors appointed by the Chair of the Board of Supervisors; one representative of local business, one citizen knowledgeable of hazardous waste disposal practices, and two citizens-at-large recommended by the commission and appointed by the Board of Supervisors; and three city/town representatives, one from each of the three incorporated cities/town, to be selected by the city/town council from their respective city/town and who shall either be a member of the city/town council or a staff member. The members of the Board of Supervisors will serve one year terms, pursuant to the August 17, 2004 Board of Supervisors meeting, all members appointed by the Board of Supervisors will serve 2 year terms, and the City/Town members will serve until replaced.
