

ORDINANCE No. 2413

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

AN ORDINANCE AMENDING SECTION G-IV 9.1 OF ARTICLE 9 OF CHAPTER IV OF THE GENERAL CODE PERTAINING TO CONCEALED FIREARMS LICENSE FEES; SECTION A-II 24.1 OF ARTICLE II OF CHAPTER 24 OF THE ADMINISTRATIVE CODE PERTAINING TO CORONER FEES FOR TRANSPORTATION OF BODIES; SECTION A-II 24.15 OF CHAPTER II OF ARTICLE 24 OF THE ADMINISTRATIVE CODE PERTAINING TO EXPLOSIVE PERMIT FEES; AND SECTION G-IX 9.3 OF ARTICLE 9 OF CHAPTER IX OF THE GENERAL CODE PERTAINING TO SPEED ZONE PERMITS AT BOCA RESERVOIR

THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA, STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:

SECTION I:

Section G-IV 9.1 of Article 9 of Chapter IV of the General Code is hereby amended to read as follows:

"Sec. G-IV 9.1 Concealed Firearm License

The Sheriff is authorized and directed to charge and collect a fee for each concealed firearm license issued by the Sheriff's Office, and a sum for each renewal of said permit, in an amount to be determined by resolution of the Board of Supervisors."

SECTION II:

Section A-II 24.1 of Article II of Chapter 24 of the Administrative Code is hereby amended to read as follows:

"Sec. A-II 24.1 Coroner Fees

In accordance with Government Code sections 27472 and 54985, the Coroner of the County of Nevada shall charge and collect a fee, the amount which reflects the actual expense incurred by the Coroner, for the removal of a body from the place of death and/or the keeping of a body until its release or interment. Such fee shall be set by resolution of the Board of Supervisors and shall be imposed in accordance with the Government Code section 27472."

SECTION III:

Section A-II 24.15 of Chapter II of Article 24 of the Administrative Code is hereby amended to read as follows:

"Sec. A-II 24.15 Coroner Fees

In accordance with Health and Safety Code section 12101, et seq, the Sheriff's Office is hereby authorized to charge and collect a fee or fees for the application for, and issuance of, an explosives permit. Such fees shall be set by resolution of the Board of Supervisors and shall be imposed in accordance with the provisions of Health and Safety Code Section 12101, et seq."

SECTION IV:

Section G-IX 9.3 of Article 9 of Chapter IX of the General Code is hereby amended to add the following as the final sentence in this section:

"Sec. G-IX 9.3 Speed Zones

* * * *

The fee for the permit shall be set by resolution of the Board of Supervisors."

This Ordinance shall take effect and be in force at the expiration of thirty (30) days from and after its passage, and it shall become operative on the and day of July , 2016, and before the expiration of fifteen (15) days after its passage it shall be published once, with the names of the Supervisors voting for and against same in the Union, a newspaper of general circulation printed and published in the County of Nevada.
