## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING REVENUE CONTRACT, COOPERATIVE AGREEMENT NO. 25-0384-000-SA, WITH THE CALIFORNIA DEPARTMENT OF FOOD AND AGRICULTURE (CDFA) FOR \$120,000 FOR THE PERIOD OF JULY 1, 2025 THROUGH JUNE 30, 2028, APPROVING A SUBRECIPIENT REIMBURSEMENT AGREEMENT WITH PLACER COUNTY IN THE AMOUNT OF \$60,000, AUTHORIZING THE NEVADA COUNTY AGRICULTURAL COMMISSIONER TO EXECUTE THE AGREEMENTS AND ALL ADDITIONAL DOCUMENTS ASSOCIATED WITH THESE AGREEMENTS ON BEHALF OF THE COUNTY OF NEVADA, AND AMENDING THE AGRICULTURAL SERVICES BUDGET FOR FISCAL YEAR 2025/26 (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the destructive impact of noxious and invasive weeds is profound, affecting Nevada County's cropland, rangeland, forests, parks, waterways, and wildlands; and

WHEREAS, these pests result in losses of private, state, and federal resources through decreased land productivity, decreased water supply, degradation of wildlife habitat, and outright destruction of crops, livestock range, wetlands, waterways, watersheds, and recreation areas; and

WHEREAS, the Nevada County Agricultural Commissioner's Office has a long-standing history of controlling noxious and invasive weeds; and

WHEREAS, in 2002, Nevada and Placer Counties formed a partnership Nevada-Placer Weed Management Area (WMA) to prevent and control noxious and invasive weeds; and

WHEREAS, the CDFA awarded \$120,000 to the Nevada-Placer WMA to reimburse efforts in controlling these noxious and invasive weeds as outlined in the agreement's project narrative; and

WHEREAS, Nevada County will act as primary recipient for the grant and enter into a reimbursement agreement with Placer County for \$60,000 over Fiscal Years 2025/26 through 2027/28; and

WHEREAS, a budget amendment for Fiscal Year 2025/26 is needed for the reimbursement amount to Placer County for the first year in the amount of \$20,000 from the grant revenues; and

WHEREAS, funds when received will be deposited into the Agricultural Services budget code 0101-20601-301-1000/441530

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors of the County of Nevada:

1. Approves Cooperative Service Agreement Number 25-03884-000-SA between the County of Nevada and the CDFA from July 1, 2025, through June 30, 2028, and authorizes the Nevada County Agricultural Commissioner to execute the agreement on behalf of the County of Nevada, plus any amendments that may be needed.

- 2. Approves Reimbursement Agreement between the County of Nevada and Placer County from July 1, 2025, through June 30, 2028, and authorizes the Nevada County Agricultural Commissioner to execute the agreement on behalf of the County of Nevada, plus any amendments that may be needed.
- 3. Directs the Auditor-Controller to amend the Fiscal Year 2025/26 budget as follows:
